16 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

1 **Sec. 1.** RCW 28A.335.180 and 1990 c 33 s 361 are each amended to
2 read as follows:

3 Notwithstanding any other provision of law, school districts,
4 educational service districts, or any other state or local governmental
5 agency concerned with education, when declaring texts and other books,
6 equipment, materials or relocatable facilities as surplus, shall, prior
7 to other disposal thereof, serve notice in writing (~~to the office of~~
8 ~~the state superintendent of public instruction~~) in a newspaper of
9 general circulation in the school district and to any public school
10 district or private school in Washington state annually requesting such
11 a notice, that the same is available for sale, rent, or lease to public
12 school districts or private schools, at depreciated cost or fair market
13 value, whichever is greater: PROVIDED, That students wishing to
14 purchase texts pursuant to RCW 28A.320.230(2) shall have priority as to
15 such texts. Such districts or agencies shall not otherwise sell, rent
16 or lease such surplus property to any person, firm, organization, or
17 nongovernmental agency for at least (~~forty-five~~) thirty days
18 following (~~the date notification is mailed to the state superintendent~~
19 ~~of public instruction~~) publication of notice in a newspaper of general
20 circulation in the school district.

21 **Sec. 2.** RCW 28A.300.040 and 1990 c 33 s 251 are each amended to
22 read as follows:

23 In addition to any other powers and duties as provided by law, the
24 powers and duties of the superintendent of public instruction shall be:

25 (1) To have supervision over all matters pertaining to the public
26 schools of the state.

27 (2) To report to the governor and the legislature such information
28 and data as may be required for the management and improvement of the
29 schools.

1 (3) To prepare and have printed such forms, registers, courses of
2 study, rules and regulations for the government of the common schools,
3 questions prepared for the examination of persons as provided for in
4 RCW 28A.305.130(9), and such other material and books as may be
5 necessary for the discharge of the duties of teachers and officials
6 charged with the administration of the laws relating to the common
7 schools, and to distribute the same to educational service district
8 superintendents.

9 (4) To travel, without neglecting his or her other official duties
10 as superintendent of public instruction, for the purpose of attending
11 educational meetings or conventions, of visiting schools, of consulting
12 educational service district superintendents or other school officials.

13 (5) To prepare and from time to time to revise a manual of the
14 Washington state common school code, copies of which shall be provided
15 in such numbers as determined by the superintendent of public
16 instruction at no cost to those public agencies within the common
17 school system and which shall be sold at approximate actual cost of
18 publication and distribution per volume to all other public and
19 nonpublic agencies or individuals, said manual to contain Titles 28A
20 and 28C RCW, rules and regulations related to the common schools, and
21 such other matter as the state superintendent or the state board of
22 education shall determine. Proceeds of the sale of such code shall be
23 transmitted to the public printer who shall credit the state
24 superintendent's account within the state printing plant revolving fund
25 by a like amount.

26 (6) To act as ex officio member and the chief executive officer of
27 the state board of education.

28 ~~(7) ((To hold, annually, a convention of the educational service~~
29 ~~district superintendents of the state at such time and place as he or~~
30 ~~she may deem convenient, for the discussion of questions pertaining to~~

1 ~~supervision and the administration of the school laws and such other~~
2 ~~subjects affecting the welfare and interests of the common schools as~~
3 ~~may be brought before it. Said convention shall continue in session at~~
4 ~~the option of the superintendent of public instruction. It shall be~~
5 ~~the duty of every educational service district superintendent in this~~
6 ~~state to attend said convention during its entire session, and any~~
7 ~~educational service district superintendent who attends the convention~~
8 ~~shall be reimbursed for traveling and subsistence expenses as provided~~
9 ~~in RCW 28A.310.320 in attending said convention.~~

10 ~~(8))~~ To file all papers, reports and public documents transmitted
11 to the superintendent by the school officials of the several counties
12 or districts of the state, each year separately. Copies of all papers
13 filed in the superintendent's office, and the superintendent's official
14 acts, may, or upon request, shall be certified by the superintendent
15 and attested by the superintendent's official seal, and when so
16 certified shall be evidence of the papers or acts so certified to.

17 ~~((9))~~ (8) To require annually, on or before the 15th day of
18 August, of the president, manager, or principal of every educational
19 institution in this state, a report ~~((of such facts arranged in such~~
20 ~~manner as the superintendent may prescribe, and the superintendent~~
21 ~~shall furnish forms for such reports))~~ as required by the
22 superintendent of public instruction; and it is ~~((hereby made))~~ the
23 duty of every president, manager or principal, to complete and return
24 such forms within such time as the superintendent of public instruction
25 shall direct.

26 ~~((10))~~ (9) To keep in the superintendent's office a record of all
27 teachers receiving certificates to teach in the common schools of this
28 state.

29 ~~((11))~~ (10) To issue certificates as provided by law.

1 (~~(12)~~) (11) To keep in the superintendent's office at the capital
2 of the state, all books and papers pertaining to the business of the
3 superintendent's office, and to keep and preserve in the
4 superintendent's office a complete record of statistics, as well as a
5 record of the meetings of the state board of education.

6 (~~(13)~~) (12) With the assistance of the office of the attorney
7 general, to decide all points of law which may be submitted to the
8 superintendent in writing by any educational service district
9 superintendent, or that may be submitted to the superintendent by any
10 other person, upon appeal from the decision of any educational service
11 district superintendent; and the superintendent shall publish his or
12 her rulings and decisions from time to time for the information of
13 school officials and teachers; and the superintendent's decision shall
14 be final unless set aside by a court of competent jurisdiction.

15 (~~(14)~~) (13) To administer oaths and affirmations in the discharge
16 of the superintendent's official duties.

17 (~~(15)~~) (14) To deliver to his or her successor, at the expiration
18 of the superintendent's term of office, all records, books, maps,
19 documents and papers of whatever kind belonging to the superintendent's
20 office or which may have been received by the superintendent's for the
21 use of the superintendent's office.

22 (~~(16)~~) (15) To perform such other duties as may be required by
23 law.

24 **Sec. 3.** RCW 28A.300.060 and 1990 c 33 s 253 are each amended to
25 read as follows:

26 (~~The legislature finds that the administration costs of school
27 districts are not sufficiently known to permit sound financial planning
28 by those affected by such costs. Accordingly, the legislature hereby
29 authorize and directs~~) The superintendent of public instruction and

1 the state auditor jointly, and in cooperation with the senate and house
2 committees on education, ~~((to))~~ shall conduct appropriate studies and
3 adopt classifications or revised classifications under RCW 28A.505.100,
4 defining what expenditures shall be charged to each budget class
5 including administration. ~~((Such))~~ The studies and classifications
6 shall be published in the form of a manual or revised manual, suitable
7 for use by the governing bodies of school districts, by the
8 superintendent of public instruction, and by the legislature.

9 **Sec. 4.** RCW 28A.155.140 and 1990 c 33 s 131 are each amended to
10 read as follows:

11 ~~((By July 1, 1989, the superintendent of public instruction shall
12 complete a study and, as may be necessary, adopt rules providing for
13 the appropriate use of curriculum-based assessment procedures as a
14 component of assessment procedures provided by RCW 28A.155.010 through
15 28A.155.100.))~~ School districts may use curriculum-based assessment
16 procedures as measures for developing academic early intervention
17 programs and curriculum planning: PROVIDED, That the use of curriculum-
18 based assessment procedures shall not deny a student the right to an
19 assessment to determine eligibility or participation in learning
20 disabilities programs as provided by RCW 28A.155.010 through
21 28A.155.100.

22 **Sec. 5.** RCW 28A.305.190 and 1973 c 51 s 2 are each amended to read
23 as follows:

24 The state board of education shall adopt rules and regulations
25 governing the conditions by and under which a certificate of
26 educational competence may be issued to a person nineteen years of age
27 or older, ~~((and))~~ or to a child fifteen years of age and under nineteen
28 years of age ~~((when such a))~~ if the child ~~((can evidence))~~ provides a

1 substantial and warranted reason for leaving the regular high school
2 education program, or if the child was home-schooled.

3 **Sec. 6.** RCW 28A.230.020 and 1988 c 206 s 403 are each amended to
4 read as follows:

5 All common schools shall give instruction in reading, penmanship,
6 orthography, written and mental arithmetic, geography, the history of
7 the United States, English grammar, physiology and hygiene with special
8 reference to the effects of ~~((alcoholic stimulants and narcotics))~~
9 alcohol and drug abuse on the human system, science with special
10 reference to the environment, and such other studies as may be
11 prescribed by rule or regulation of the state board of education. All
12 teachers shall stress the importance of the cultivation of manners, the
13 fundamental principles of honesty, honor, industry and economy, the
14 minimum requisites for good health including the beneficial effect of
15 physical exercise and methods to prevent exposure to and transmission
16 of sexually transmitted diseases, and the worth of kindness to all
17 living creatures and the land. The prevention of child abuse may be
18 offered as part of the curriculum in the common schools.

19 **Sec. 7.** RCW 28A.230.060 and 1969 ex.s. c 57 s 2 are each amended
20 to read as follows:

21 ~~((To promote good citizenship and a greater interest in and better
22 understanding of our national and state institutions and system of
23 government, the state board of education shall prescribe a one year
24 course of study in the history and government of the United States, and
25 the equivalent of a one semester course of study in the state of
26 Washington's history and government. No person shall be graduated from
27 high school without completing such courses of study: PROVIDED, That))~~
28 Students in the twelfth grade who have not completed ((such)) a course

1 of study in Washington's history and state government because of
2 previous residence outside the state may have the ((foregoing))
3 requirement in RCW 28A.230.090 waived by their principal.

4 **Sec. 8.** RCW 28A.230.100 and 1990 c 33 s 239 are each amended to
5 read as follows:

6 The state board of education shall adopt rules pursuant to chapter
7 34.05 RCW, to implement the course requirements set forth in RCW
8 28A.230.090. ((Such)) The rules shall include, as the state board
9 deems necessary, granting equivalencies for and temporary exemptions
10 from the course requirements in RCW 28A.230.090 and special alterations
11 of the course requirements in RCW 28A.230.090. In developing such rules
12 the state board shall recognize the relevance of vocational and applied
13 courses and allow such courses to fulfill in whole or in part the
14 courses required for graduation in RCW 28A.230.090. ((Such)) The rules
15 may include provisions for competency testing in lieu of such courses
16 required for graduation in RCW 28A.230.090 or demonstration of specific
17 skill proficiency or understanding of concepts through work or
18 experience.

19 **Sec. 9.** RCW 28A.230.130 and 1988 c 172 s 2 are each amended to
20 read as follows:

21 (1) All public high schools of the state shall provide a program,
22 directly or ((otherwise)) in cooperation with a community college or
23 another school district, for students whose educational plans include
24 application for entrance to a baccalaureate-granting institution after
25 being granted a high school diploma. The program shall help these
26 students to meet at least the minimum entrance requirements under RCW
27 28B.10.050.

1 (2) The state board of education, upon request from local school
2 districts, (~~(shall be authorized to)~~) may grant temporary exemptions
3 from (~~(providing)~~) the requirements to provide the program described in
4 subsection (1) of this section for reasons relating to school district
5 size and the availability of staff authorized to teach subjects which
6 must be provided.

7 **Sec. 10.** RCW 28A.150.260 and 1990 c 33 s 108 are each amended to
8 read as follows:

9 The basic education allocation for each annual average full time
10 equivalent student shall be determined in accordance with the following
11 procedures:

12 (1) The governor shall and the superintendent of public instruction
13 may recommend to the legislature a formula based on a ratio of students
14 to staff for the distribution of a basic education allocation for each
15 annual average full time equivalent student enrolled in a common
16 school. The distribution formula shall have the primary objective of
17 equalizing educational opportunities and shall provide appropriate
18 recognition of the following costs among the various districts within
19 the state:

20 (a) Certificated instructional staff and their related costs;

21 (b) Certificated administrative staff and their related costs;

22 (c) Classified staff and their related costs;

23 (d) Nonsalary costs;

24 (e) Extraordinary costs of remote and necessary schools and small
25 high schools, including costs of additional certificated and classified
26 staff; and

27 (f) The attendance of students pursuant to RCW 28A.335.160 and
28 28A.225.250 who do not reside within the servicing school district.

1 (2)(a) This formula for distribution of basic education funds shall
2 be reviewed biennially by the superintendent and governor. The
3 recommended formula shall be subject to approval, amendment or
4 rejection by the legislature. The formula shall be for allocation
5 purposes only. While the legislature intends that the allocations for
6 additional instructional staff be used to increase the ratio of such
7 staff to students, nothing in this section shall require districts to
8 reduce the number of administrative staff below existing levels.

9 (b) ~~((The formula adopted by the legislature for the 1987-88 school
10 year shall reflect the following ratios at a minimum: (i) Forty-eight
11 certificated instructional staff to one thousand annual average full
12 time equivalent students enrolled in grades kindergarten through three;
13 (ii) forty-six certificated instructional staff to one thousand annual
14 average full time equivalent students enrolled in grades four through
15 twelve; (iii) four certificated administrative staff to one thousand
16 annual average full time equivalent students enrolled in grades
17 kindergarten through twelve; and (iv) sixteen and sixty-seven one-
18 hundredths classified personnel to one thousand annual average full
19 time equivalent students enrolled in grades kindergarten through
20 twelve.~~

21 (e)) Commencing with the 1988-89 school year, the formula adopted
22 by the legislature shall reflect the following ratios at a minimum:
23 (i) Forty-nine certificated instructional staff to one thousand annual
24 average full time equivalent students enrolled in grades kindergarten
25 through three; (ii) forty-six certificated instructional staff to one
26 thousand annual average full time equivalent students in grades four
27 through twelve; (iii) four certificated administrative staff to one
28 thousand annual average full time equivalent students in grades
29 kindergarten through twelve; and (iv) sixteen and sixty-seven one-
30 hundredths classified personnel to one thousand annual average full

1 time equivalent students enrolled in grades kindergarten through
2 twelve.

3 (~~(d)~~) (c) In the event the legislature rejects the distribution
4 formula recommended by the governor, without adopting a new
5 distribution formula, the distribution formula for the previous school
6 year shall remain in effect: PROVIDED, That the distribution formula
7 developed pursuant to this section shall be for state apportionment and
8 equalization purposes only and shall not be construed as mandating
9 specific operational functions of local school districts other than
10 those program requirements identified in RCW 28A.150.220 and
11 28A.150.100. The enrollment of any district shall be the annual
12 average number of full time equivalent students and part time students
13 as provided in RCW 28A.150.350, enrolled on the first school day of
14 each month and shall exclude full time equivalent handicapped students
15 recognized for the purposes of allocation of state funds for programs
16 under RCW 28A.155.010 through 28A.155.100. The definition of full time
17 equivalent student shall be determined by rules and regulations of the
18 superintendent of public instruction: PROVIDED, That the definition
19 shall be included as part of the superintendent's biennial budget
20 request: PROVIDED, FURTHER, That any revision of the present
21 definition shall not take effect until approved by the house
22 appropriations committee and the senate ways and means committee:
23 PROVIDED, FURTHER, That the office of financial management shall make
24 a monthly review of the superintendent's reported full time equivalent
25 students in the common schools in conjunction with RCW 43.62.050.

26 (3) (a) Certificated instructional staff shall include those
27 persons employed by a school district who are nonsupervisory employees
28 within the meaning of RCW 41.59.020(8): PROVIDED, That in exceptional
29 cases, people of unusual competence but without certification may teach
30 students so long as a certificated person exercises general

1 supervision: PROVIDED, FURTHER, That the hiring of such
2 noncertificated people shall not occur during a labor dispute and such
3 noncertificated people shall not be hired to replace certificated
4 employees during a labor dispute.

5 (b) Certificated administrative staff shall include all those
6 persons who are chief executive officers, chief administrative
7 officers, confidential employees, supervisors, principals, or assistant
8 principals within the meaning of RCW 41.59.020(4).

9 (4) Each annual average full time equivalent certificated classroom
10 teacher's direct classroom contact hours shall average at least twenty-
11 five hours per week. Direct classroom contact hours shall be exclusive
12 of time required to be spent for preparation, conferences, or any other
13 nonclassroom instruction duties. Up to two hundred minutes per week may
14 be deducted from the twenty-five contact hour requirement, at the
15 discretion of the school district board of directors, to accommodate
16 authorized teacher/parent-guardian conferences, recess, passing time
17 between classes, and informal instructional activity. Implementing
18 rules to be adopted by the state board of education pursuant to RCW
19 28A.150.220(6) shall provide that compliance with the direct contact
20 hour requirement shall be based upon teachers' normally assigned weekly
21 instructional schedules, as assigned by the district administration.
22 Additional record-keeping by classroom teachers as a means of
23 accounting for contact hours shall not be required. However, upon
24 request from the board of directors of any school district, the
25 provisions relating to direct classroom contact hours for individual
26 teachers in that district may be waived by the state board of education
27 if the waiver is necessary to implement a locally approved plan for
28 educational excellence and the waiver is limited to those individual
29 teachers approved in the local plan for educational excellence. The
30 state board of education shall develop criteria to evaluate the need

1 for the waiver. Granting of the waiver shall depend upon verification
2 that: (a) The students' classroom instructional time will not be
3 reduced; and (b) the teacher's expertise is critical to the success of
4 the local plan for excellence.

5 **Sec. 11.** RCW 28A.305.130 and 1990 c 33 s 266 are each amended to
6 read as follows:

7 In addition to any other powers and duties as provided by law, the
8 state board of education shall:

9 (1) Approve or disapprove the program of courses leading to
10 teacher, school administrator, and school specialized personnel
11 certification offered by all institutions of higher education within
12 the state which may be accredited and whose graduates may become
13 entitled to receive such certification.

14 (2) Conduct every five years a review of the program approval
15 standards, including the minimum standards for teachers,
16 administrators, and educational staff associates, to reflect research
17 findings and assure continued improvement of preparation programs for
18 teachers, administrators, and educational staff associates.

19 (3) Investigate the character of the work required to be performed
20 as a condition of entrance to and graduation from any institution of
21 higher education in this state relative to such certification as
22 provided for in subsection (1) above, and prepare a list of accredited
23 institutions of higher education of this and other states whose
24 graduates may be awarded such certificates.

25 (4)(a) The state board of education shall adopt rules to allow a
26 teacher certification candidate to fulfill, in part, teacher
27 preparation program requirements through work experience as a
28 noncertificated teacher's aide in a public school or private school
29 meeting the requirements of RCW 28A.195.010. The rules shall include,

1 but are not limited to, limitations based upon the recency of the
2 teacher preparation candidate's teacher aide work experience, and
3 limitations based on the amount of work experience that may apply
4 toward teacher preparation program requirements under this chapter.

5 (b) The state board of education shall require that at the time of
6 the individual's enrollment in a teacher preparation program, the
7 supervising teacher and the building principal shall jointly provide to
8 the teacher preparation program of the higher education institution at
9 which the teacher candidate is enrolled, a written assessment of the
10 performance of the teacher candidate. The assessment shall contain
11 such information as determined by the state board of education and
12 shall include: Evidence that at least fifty percent of the candidate's
13 work as a noncertificated teacher's aide was involved in instructional
14 activities with children under the supervision of a certificated
15 teacher and that the candidate worked a minimum of six hundred thirty
16 hours for one school year; the type of work performed by the candidate;
17 and a recommendation of whether the candidate's work experience as a
18 noncertificated teacher's aide should be substituted for teacher
19 preparation program requirements. In compliance with such rules as may
20 be established by the state board of education under this section, the
21 teacher preparation programs of the higher education institution where
22 the candidate is enrolled shall make the final determination as to what
23 teacher preparation program requirements may be fulfilled by teacher
24 aide work experience.

25 (5) Supervise the issuance of such certificates as provided for in
26 subsection (1) above and specify the types and kinds of certificates
27 necessary for the several departments of the common schools by rule or
28 regulation in accordance with RCW 28A.410.010.

29 (6) Accredite, subject to such accreditation standards and
30 procedures as may be established by the state board of education, all

1 schools that apply for accreditation, and approve, subject to the
2 provisions of RCW 28A.195.010, private schools carrying out a program
3 for any or all of the grades one through twelve: PROVIDED, That no
4 public or private schools shall be placed upon the list of accredited
5 schools so long as secret societies are knowingly allowed to exist
6 among its students by school officials: PROVIDED FURTHER, That the
7 state board may elect to require all or certain classifications of the
8 public schools to conduct and participate in such pre-accreditation
9 examination and evaluation processes as may now or hereafter be
10 established by the board.

11 (7) Make rules and regulations governing the establishment in any
12 existing nonhigh school district of any secondary program or any new
13 grades in grades nine through twelve. Before any such program or any
14 new grades are established the district must obtain prior approval of
15 the state board.

16 (8) Prepare such outline of study for the common schools as the
17 board shall deem necessary, and prescribe such rules for the general
18 government of the common schools, as shall seek to secure regularity of
19 attendance, prevent truancy, secure efficiency, and promote the true
20 interest of the common schools.

21 ~~(9) ((Prepare with the assistance of the superintendent of public
22 instruction a uniform series of questions, with the proper answers
23 thereto for use in the correcting thereof, to be used in the
24 examination of persons, as this code may direct, and prescribe rules
25 and regulations for conducting any such examinations.~~

26 ~~(10))~~ Continuously reevaluate courses and adopt and enforce
27 regulations within the common schools so as to meet the educational
28 needs of students and articulate with the institutions of higher
29 education and unify the work of the public school system.

1 (~~(11)~~) (10) Carry out board powers and duties relating to the
2 organization and reorganization of school districts under RCW
3 28A.315.010 through 28A.315.680 and 28A.315.900.

4 (~~(12)~~) (11) By rule or regulation promulgated upon the advice of
5 the director of community development, through the director of fire
6 protection, provide for instruction of pupils in the public and private
7 schools carrying out a K through 12 program, or any part thereof, so
8 that in case of sudden emergency they shall be able to leave their
9 particular school building in the shortest possible time or take such
10 other steps as the particular emergency demands, and without confusion
11 or panic; such rules and regulations shall be published and distributed
