- 1 AN ACT Relating to military leave for public employees; amending
- 2 RCW 38.40.060; creating a new section; and declaring an emergency.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 38.40.060 and 1989 c 19 s 50 are each amended to read
- 5 as follows:
- 6 Every officer and employee of the state or of any county, city, or
- 7 other political subdivision thereof who is a member of the Washington
- 8 national guard or of the army, navy, air force, coast guard, or marine
- 9 corps reserve of the United States, or of any organized reserve or
- 10 armed forces of the United States shall be entitled to and shall be
- 11 granted military leave of absence from such employment for a period not
- 12 exceeding fifteen days during each calendar year. Such leave shall be
- 13 granted in order that the person may report for active duty, when
- 14 <u>called</u>, or take part in active training duty in such manner and at such
- 15 time as he <u>or she</u> may be ordered to <u>active duty or</u> active training

- 1 duty. Such military leave of absence shall be in addition to any
- 2 vacation or sick leave to which the officer or employee might otherwise
- 3 be entitled, and shall not involve any loss of efficiency rating,
- 4 privileges, or pay. During the period of military leave, the officer
- 5 or employee shall receive from the state, or the county, city, or other
- 6 political subdivision, his or her normal pay.
- 7 <u>NEW SECTION.</u> **Sec. 2.** This act applies to all public employees
- 8 and officers who reported for active duty or active training duty,
- 9 under RCW 38.40.060, on or after August 2, 1990.
- 10 <u>NEW SECTION</u>. **Sec. 3**. This act is necessary for the immediate
- 11 preservation of the public peace, health, or safety, or support of the
- 12 state government and its existing public institutions, and shall take
- 13 effect immediately.
