Read first time February 26, 1991.

- 1 AN ACT Relating to water systems operator certification and
- 2 registration; amending RCW 70.119.010, 70.119.020, 70.119.030,
- 3 70.119.060, 70.119.090, 70.119.100, 70.119.110, and 70.119.130; and
- 4 prescribing penalties.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 **Sec. 1.** RCW 70.119.010 and 1983 c 292 s 1 are each amended to read
- 7 as follows:
- 8 The legislature declares that competent operation of a public water
- 9 ((supply)) system is necessary for the protection of the consumers'
- 10 health, and therefore it is of vital interest to the public. In order
- 11 to protect the public health and conserve and protect the water
- 12 resources of the state, it is necessary to provide for the classifying
- 13 of all public water ((supply)) systems; to require the examination and
- 14 certification of the persons responsible for the technical operation of

- 1 such systems; and to provide for the promulgation of rules and
- 2 regulations to carry out this chapter.
- 3 Sec. 2. RCW 70.119.020 and 1991 c 3 s 369 are each amended to read
- 4 as follows:
- 5 As used in this chapter unless context requires another meaning:
- 6 (1) "Board" means the board established pursuant to RCW 70.95B.070
- 7 which shall be known as the water and waste water operator
- 8 certification board of examiners.
- 9 (2) "Certificate" means a certificate of competency issued by the
- 10 secretary stating that the operator has met the requirements for the
- 11 specified operator classification of the certification program.
- 12 (3) "Certified operator" means an individual holding a valid
- 13 certificate and employed or appointed by any county, water district,
- 14 municipality, public or private corporation, company, institution,
- 15 person, or the state of Washington and who is designated by the
- 16 employing or appointing officials as the person responsible for active
- 17 daily technical operation.
- 18 (4) "Department" means the department of health.
- 19 (((4))) (5) "Distribution system" means that portion of a public
- 20 water ((supply)) system which stores, transmits, pumps and distributes
- 21 water to consumers.
- 22 (((5))) <u>(6) "Ground water under the direct influence of surface</u>
- 23 water means any water beneath the surface of the ground with:
- 24 (a) Significant occurrence of insects or other macroorganisms,
- 25 algae, or large diameter pathogens such as giardia lamblia; or
- 26 (b) Significant and relatively rapid shifts in water
- 27 characteristics such as turbidity, temperature, conductivity, or pH
- 28 which closely correlate to climatological or surface water conditions.

- 1 (7) "Group A water system" means a system with fifteen or more
- 2 service connections, regardless of the number of people; or a system
- 3 serving an average of twenty-five or more people per day for sixty or
- 4 more days within a calendar year, regardless of the number of service
- 5 connections. Group A water system does not include a system serving
- 6 fewer than fifteen single-family residences, regardless of the number
- 7 of people.
- 8 (8) "Nationally recognized association of certification
- 9 authorities" shall mean an organization which serves as an information
- 10 center for certification activities, recommends minimum standards and
- 11 guidelines for classification of potable water treatment plants, water
- 12 distribution systems and waste water facilities and certification of
- 13 operators, facilitates reciprocity between state programs and assists
- 14 authorities in establishing new certification programs and updating
- 15 existing ones.
- 16 (((6) "Certified operator" means an individual employed or
- 17 appointed by any county, water district, municipality, public or
- 18 private corporation, company, institution, person, or the state of
- 19 Washington who is designated by the employing or appointing officials
- 20 as the person responsible for active daily technical operation.
- 21 (7)) (9) "Public water ((supply)) system" means any ((water supply
- 22 system intended or used for human consumption or other domestic uses,
- 23 including source, treatment, storage, transmission and distribution
- 24 facilities where water is furnished to any community or group of
- 25 individuals, or is made available to the public for human consumption
- 26 or domestic use, but excluding all water supply systems serving one
- 27 single family residence)) system, excluding a system serving only one
- 28 <u>single-family residence and a system with four or fewer connections all</u>
- 29 of which serve residences on the same farm, providing piped water for
- 30 <u>human consumption</u>, including any collection, treatment, storage, or

- 1 distribution facilities under control of the purveyor and used
- 2 primarily in connection with the system; and collection or pretreatment
- 3 storage facilities not under control of the purveyor but primarily used
- 4 in connection with the system.
- 5 $((\frac{8}{10}))$ (10) "Purification plant" means that portion of a public
- 6 water ((supply)) system which treats or improves the physical, chemical
- 7 or bacteriological quality of the system's water to bring the water
- 8 into compliance with state board of health standards.
- 9 $((\frac{9}{1}))$ "Secretary" means the secretary of the department of
- 10 health.
- 11 (12) "Service" means a connection to a public water system designed
- 12 to serve a single-family residence, dwelling unit, or equivalent use.
- 13 If the facility has group home or barracks-type accommodations, three
- 14 persons will be considered equivalent to one service.
- 15 (13) "Surface water" means all water open to the atmosphere and
- 16 <u>subject to surface runoff</u>.
- 17 **Sec. 3.** RCW 70.119.030 and 1983 c 292 s 3 are each amended to read
- 18 as follows:
- 19 (1) ((All public water supply systems which serve either)) A public
- 20 <u>water system shall have a certified operator if</u>:
- 21 (a) The system serves one hundred or more services in use at any
- 22 one time; or
- 23 (b) ((Twenty-five or more persons which are supplied from a stream,
- 24 lake or other surface water supply source and which are required by law
- 25 to use a water filtration system;
- 26 are required to have a certified operator)) It is a group A water
- 27 system using a surface water source or a ground water source under the
- 28 <u>direct influence of surface water</u>.

- 1 (2) The certified operators shall be in charge of the technical
- 2 direction of a water system's operation, or an operating shift of such
- 3 a system, or a major segment of a system necessary for monitoring or
- 4 improving the quality of water. The operator shall be certified as
- 5 provided in RCW 70.119.050.
- 6 $((\frac{2}{2}))$ 1 The amount of time that a certified operator shall be
- 7 required to be present shall be based upon the time required to
- 8 properly operate and maintain the public water ((supply)) system as
- 9 designed and constructed in accordance with RCW 43.20.050. The
- 10 employing or appointing officials shall designate the position or
- 11 positions requiring mandatory certification within their individual
- 12 systems and shall assure that such certified operators are responsible
- 13 for the system's technical operation.
- (((3))) (4) Operators not required to be certified by this chapter
- 15 are encouraged to become certified on a voluntary basis.
- 16 **Sec. 4.** RCW 70.119.060 and 1977 ex.s. c 99 s 6 are each amended to
- 17 read as follows:
- 18 The secretary shall further categorize all public water ((supply))
- 19 systems with regard to the size, type, source of water, and other
- 20 relevant physical conditions affecting purification plants and
- 21 distribution systems to assist in identifying the skills, knowledge and
- 22 experience required for the certification of operators for each
- 23 category of such systems, to assure the protection of the public health
- 24 and conservation and protection of the state's water resources as
- 25 required under RCW 70.119.010, and to implement the provisions of the
- 26 state safe drinking water act in chapter 70.119A RCW. In categorizing
- 27 <u>all public water systems for the purpose of implementing these</u>
- 28 provisions of state law, the secretary shall take into consideration

- 1 economic impacts as well as the degree and nature of any public health
- 2 risk.
- 3 Sec. 5. RCW 70.119.090 and 1983 c 292 s 7 are each amended to read
- 4 as follows:
- 5 Certificates shall be issued without examination under the
- 6 following conditions:
- 7 (1) Certificates shall be issued without application fee to
- 8 operators who, on ((the effective date of this act)) January 1, 1978,
- 9 hold certificates of competency attained under the voluntary
- 10 certification program sponsored jointly by the state department of
- 11 social and health services, health services division, and the Pacific
- 12 Northwest section of the American water works association.
- 13 (2) Certification shall be issued to persons certified by a
- 14 governing body or owner of a public water ((supply)) system to have
- 15 been the operators of a purification plant or distribution system on
- 16 ((the effective date of this chapter)) January 1, 1978, but only to
- 17 those who are required to be certified under RCW 70.119.030(1). A
- 18 certificate so issued shall be valid for operating any plant or system
- 19 of the same classification and same type of water source.
- 20 (3) A nonrenewable certificate, temporary in nature, may be issued
- 21 to an operator for a period not to exceed twelve months to fill a
- 22 vacated position required to have a certified operator. Only one such
- 23 certificate may be issued subsequent to each instance of vacation of
- 24 any such position.
- 25 Sec. 6. RCW 70.119.100 and 1987 c 75 s 11 are each amended to read
- 26 as follows:
- 27 The issuance and renewal of a certificate shall be subject to the
- 28 following conditions:

- 1 (1) Except as provided in RCW 70.119.090, a certificate shall be
- 2 issued if the operator has satisfactorily passed a written examination,
- 3 has paid the department an application fee as established by the
- 4 department under RCW ((43.20B.110)) 43.70.110, and has met the
- 5 requirements specified in the rules and regulations as authorized by
- 6 this chapter.
- 7 (2) ((The terms for all certificates shall be for one year from the
- 8 date of issuance.)) Every certificate shall be renewed annually upon
- 9 the payment of a fee as established by the department under RCW
- 10 ((43.20B.110)) 43.70.110 and satisfactory evidence is presented to the
- 11 secretary that the operator has fulfilled the continuing education
- 12 requirements as prescribed by rule of the department.
- 13 (3) The secretary shall notify operators who fail to renew their
- 14 certificates before the end of the ((certificate)) year that their
- 15 certificates are temporarily valid for two months following the end of
- 16 the certificate year. Certificates not renewed during the two month
- 17 period shall be invalid and the secretary shall so notify the holders
- 18 of such certificates.
- 19 (4) An operator who has failed to renew a certificate pursuant to
- 20 the provisions of this section, may reapply for certification and the
- 21 secretary may require the operator to meet the requirements established
- 22 for new applicants.
- 23 Sec. 7. RCW 70.119.110 and 1983 c 292 s 9 are each amended to read
- 24 as follows:
- The secretary may, with the recommendation of the board and after
- 26 hearing before the same, revoke a certificate found to have been
- 27 obtained by fraud or deceit; or for gross negligence in the operation
- 28 of a purification plant or distribution system; or for an intentional
- 29 violation of the requirements of this chapter or any lawful rules,

- 1 order, or regulation of the department. No person whose certificate is
- 2 revoked under this section shall be eligible to apply for a certificate
- 3 for ((six months)) one year from the effective date of the final order
- 4 of revocation.
- 5 **Sec. 8.** RCW 70.119.130 and 1983 c 292 s 10 are each amended to
- 6 read as follows:
- 7 ((On or after one year following the effective date of this act,))
- 8 Any person, including any operator or any firm, association,
- 9 corporation, municipal corporation, or other governmental subdivision
- 10 or agency who, after thirty days' written notice, operates a public
- 11 water ((supply)) system which is not in compliance with RCW
- 12 70.119.030(1), shall be guilty of a misdemeanor. Each month of such
- 13 operation out of compliance with RCW 70.119.030(1) shall constitute a
- 14 separate offense. Upon conviction, violators shall be fined an amount
- 15 not exceeding one hundred dollars for each offense. It shall be the
- 16 duty of the prosecuting attorney or the attorney general, as
- 17 appropriate to secure injunctions of continuing violations of any
- 18 provisions of this chapter or the rules and regulations adopted
- 19 hereunder: PROVIDED, That, except in the case of fraud, deceit, or
- 20 gross negligence under RCW 70.119.110, no revocation, citation or
- 21 charge shall be made under RCW 70.119.110 and 70.119.130 until a proper
- 22 written notice of violation is received and a reasonable opportunity
- 23 for correction has been given.
