Read first time February 28, 1991. Referred to Committee on Appropriations.

1 AN ACT Relating to notification to public employees of accumulated
2 service credit by the department of retirement systems; and amending
3 RCW 41.50.065.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 41.50.065 and 1990 c 8 s 2 are each amended to read
6 as follows:

7 (1) The department shall annually notify each member of each
8 retirement system listed in RCW 41.50.030 of his or her:

9 (a) Service credit accumulated in the preceding calendar year; and

10 (b) Total service credit accumulated.

11 (2) The department shall begin notifying members under this section
12 (~~no later than October 1, 1993. The department shall initially~~
13 ~~concentrate on auditing members who are within five years of being~~
14 ~~eligible for service retirement~~)) according to the following schedule:

1 (a) All members of the teachers' retirement system shall begin
2 receiving annual notification of accumulated service credit and service
3 credit earned within the preceding school year or one school year, as
4 appropriate, no later than January 1, 1991;

5 (b) All members, other than members of the teachers' retirement
6 system, shall begin receiving annual notification of service credit
7 accumulated within the preceding calendar year or school year, as
8 appropriate, no later than June 30, 1992;

9 (c) All members within five years of being eligible for service
10 retirement shall begin receiving annual notification of total service
11 credit accumulated no later than October 1, 1993;

12 (d) Members, other than members of the teachers' retirement system,
13 who are not within five years of being eligible for service retirement
14 shall begin receiving annual notification of total service credit
15 accumulated according to the following schedule:

16 (i) For members of the law enforcement officers' and fire fighters'
17 retirement system, Washington state patrol retirement system, judicial
18 retirement system, and judges' retirement system, no later than August
19 30, 1993;

20 (ii) For employees of the state of Washington who are members of
21 the public employees' retirement system, no later than August 30, 1994;

22 (iii) For employees of political subdivisions of the state of
23 Washington, no later than January 31, 1995;

24 (iv) For employees of institutions of higher education as defined
25 in RCW 28B.10.016, no later than June 30, 1995; and

26 (v) For school district employees who are members of the public
27 employees' retirement system, no later than April 30, 1996.

28 (3) The department shall adopt rules implementing this section.
