Read first time March 1, 1991. Referred to Committee on Commerce & Labor.

- 1 AN ACT Relating to the lottery; amending RCW 67.70.040; and
- 2 declaring an emergency.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 67.70.040 and 1988 c 289 s 801 are each amended to
- 5 read as follows:
- 6 The commission shall have the power, and it shall be its duty:
- 7 (1) To promulgate such rules governing the establishment and
- 8 operation of a state lottery as it deems necessary and desirable in
- 9 order that such a lottery be initiated at the earliest feasible and
- 10 practicable time, and in order that such lottery produce the maximum
- 11 amount of net revenues for the state consonant with the dignity of the
- 12 state and the general welfare of the people. Such rules shall include,
- 13 but shall not be limited to, the following:
- 14 (a) The type of lottery to be conducted which may include the
- 15 selling of tickets or shares((<del>, or</del>)). The use of electronic or

- 1 mechanical devices or video terminals which ((do not require a printed
- 2 ticket: PROVIDED, That)) allow for individual play against such
- 3 <u>devices or terminals shall be prohibited</u>. Approval of the legislature
- 4 shall be required before entering any agreement with other state
- 5 lotteries to conduct shared games;
- 6 (b) The price, or prices, of tickets or shares in the lottery;
- 7 (c) The numbers and sizes of the prizes on the winning tickets or
- 8 shares;
- 9 (d) The manner of selecting the winning tickets or shares;
- 10 (e) The manner and time of payment of prizes to the holder of
- 11 winning tickets or shares which, at the director's option, may be paid
- 12 in lump sum amounts or installments over a period of years;
- 13 (f) The frequency of the drawings or selections of winning tickets
- 14 or shares, without limitation;
- 15 (g) Without limit as to number, the type or types of locations at
- 16 which tickets or shares may be sold;
- 17 (h) The method to be used in selling tickets or shares((, which may
- 18 include the use of electronic or mechanical devices and video
- 19 terminals));
- 20 (i) The licensing of agents to sell or distribute tickets or
- 21 shares, except that a person under the age of eighteen shall not be
- 22 licensed as an agent;
- 23 (j) The manner and amount of compensation, if any, to be paid
- 24 licensed sales agents necessary to provide for the adequate
- 25 availability of tickets or shares to prospective buyers and for the
- 26 convenience of the public;
- (k) The apportionment of the total revenues accruing from the sale
- 28 of lottery tickets or shares and from all other sources among: (i) The
- 29 payment of prizes to the holders of winning tickets or shares, which
- 30 shall not be less than forty-five percent of the gross annual revenue

- 1 from such lottery, less amounts of unclaimed prizes deposited in the
- 2 general fund under RCW 67.70.190 during the fiscal year ending June 30,
- 3 1989, (ii) transfers to the lottery administrative account created by
- 4 RCW 67.70.260, and (iii) transfer to the state's general fund.
- 5 Transfers to the state general fund shall be made in compliance with
- 6 RCW 43.01.050;
- 7 (1) Such other matters necessary or desirable for the efficient and
- 8 economical operation and administration of the lottery and for the
- 9 convenience of the purchasers of tickets or shares and the holders of
- 10 winning tickets or shares.
- 11 (2) To ensure that in each place authorized to sell lottery tickets
- 12 or shares, on the back of the ticket or share, and in any advertising
- 13 or promotion there shall be conspicuously displayed an estimate of the
- 14 probability of purchasing a winning ticket.
- 15 (3) To amend, repeal, or supplement any such rules from time to
- 16 time as it deems necessary or desirable.
- 17 (4) To advise and make recommendations to the director for the
- 18 operation and administration of the lottery.
- 19 <u>NEW SECTION.</u> **Sec. 2.** This act is necessary for the immediate
- 20 preservation of the public peace, health, or safety, or support of the
- 21 state government and its existing public institutions, and shall take
- 22 effect immediately.
