- 1 AN ACT Relating to limited dental practice for University of
- 2 Washington dental residents; and amending RCW 18.32.195.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 18.32.195 and 1991 c 3 s 69 are each amended to read
- 5 as follows:
- 6 The board may, without examination, issue a license to persons who
- 7 possess the qualifications set forth in this section.
- 8 (1) The board may, upon written request of the dean of the school
- 9 of dentistry of the University of Washington, issue a license to
- 10 practice dentistry in this state to persons who have been licensed or
- 11 otherwise authorized to practice dentistry in another state or country
- 12 and who have been accepted for employment by the school of dentistry as
- 13 full-time faculty members. For purposes of this ((section))
- 14 <u>subsection</u>, this means teaching members of the faculty of the school of

- 1 dentistry of the University of Washington who are so employed on a one
- 2 hundred percent of work time basis. Such license shall permit the
- 3 holder thereof to practice dentistry within the confines of the
- 4 university facilities for a period of one year while he or she is so
- 5 employed as a full-time faculty member by the school of dentistry of
- 6 the University of Washington. It shall terminate whenever the holder
- 7 ceases to be such a full-time faculty member. Such license shall
- 8 permit the holder thereof to practice dentistry only in connection with
- 9 his or her duties in employment with the school of dentistry of the
- 10 University of Washington. This limitation shall be stated on the
- 11 license.
- 12 (2) The board may, upon written request of the dean of the school
- 13 of dentistry of the University of Washington, issue a limited license
- 14 to practice dentistry in this state to university residents in
- 15 postgraduate dental education. The license shall permit the resident
- 16 dentist to provide dental care only in connection with his or her
- 17 <u>duties as a university resident.</u>
- 18 (3) The board may condition the granting of ((such)) a license
- 19 under this section with terms the board deems appropriate. All persons
- 20 licensed under this section shall be subject to the jurisdiction of the
- 21 dental disciplinary board to the same extent as other members of the
- 22 dental profession, in accordance with this chapter, and in addition the
- 23 licensee may be disciplined by the dental disciplinary board after a
- 24 hearing has been held in accordance with the provisions set forth in
- 25 this chapter, and determination by the dental disciplinary board that
- 26 such licensee has violated any of the restrictions set forth in this
- 27 section.
- (((3))) <u>(4)</u> Persons applying for licensure pursuant to this section
- 29 shall pay the application fee determined by the secretary and, in the
- 30 event the license applied for is issued, a license fee at the rate

- 1 provided for licenses generally. After review by the board of dental
- 2 examiners, licenses issued under this section may be renewed annually
- 3 if the licensee continues to be employed as a full-time faculty member
- 4 of the school of dentistry of the University of Washington, or a
- 5 <u>university resident in postgraduate dental education</u>, and otherwise
- 6 meets the requirements of the provisions and conditions deemed
- 7 appropriate by the board of dental examiners. Any person who obtains
- 8 a license pursuant to this section may, without an additional
- 9 application fee, apply for licensure under this chapter, in which case
- 10 the applicant shall be subject to examination and the other
- 11 requirements of this chapter.
