Read first time 02/11/92.

- 1 AN ACT Relating to establishing pension credit for law enforcement
- 2 officers and fire fighters who qualified under a prior pension system;
- 3 adding new sections to chapter 41.26 RCW; adding new sections to
- 4 chapter 41.40 RCW; and declaring an emergency.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 41.26 RCW
- 7 under the subchapter heading "PLAN I" to read as follows:
- 8 If a member of plan I served as a law enforcement officer or fire
- 9 fighter under a prior pension system and that service is not creditable
- 10 to plan I because the member withdrew his or her contributions plus
- 11 accrued interest from the prior pension system, the member's prior
- 12 service as a law enforcement officer shall be credited to plan I if the
- 13 member pays to the retirement system by June 30, 1993, an amount equal

- 1 to that which the member withdrew from the prior pension system
- 2 together with interest as determined by the director.
- 3 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 41.26 RCW
- 4 under the subchapter heading "PLAN I" to read as follows:
- If a plan I member's prior service as a law enforcement officer or
- 6 fire fighter under a prior pension system is not creditable because,
- 7 although employed in a position covered by a prior pension act, the
- 8 member had not yet become a member of the pension system governed by
- 9 the act, the member's prior service as a law enforcement officer or
- 10 fire fighter shall be creditable under plan I, if the member pays to
- 11 the plan, on or before June 30, 1993, an amount equal to the employee's
- 12 and the employer's contributions that would have been required under
- 13 the prior act when the member's service was rendered if the member had
- 14 been a member of the prior pension system during that period, together
- 15 with interest as determined by the director.
- 16 NEW SECTION. Sec. 3. A new section is added to chapter 41.40 RCW
- 17 to read as follows:
- 18 Any active member of this retirement system who has previously
- 19 established ten or more years' service credit in the city of Seattle's
- 20 police relief and pension fund system, who withdrew his or her
- 21 contributions from Seattle's police relief and pension fund system
- 22 prior to July 1, 1961, and who has never been a member of the law
- 23 enforcement officers' and fire fighters' pension system created in
- 24 chapter 41.26 RCW, may receive credit in this retirement system for
- 25 such service, subject to the terms and conditions specified in section
- 26 4 of this act.

- 1 <u>NEW SECTION.</u> **Sec. 4.** A new section is added to chapter 41.40 RCW
- 2 to read as follows:
- 3 (1) A member who fulfills the requirements of section 3 of this act
- 4 may file a written declaration no later than September 30, 1992, with
- 5 the department and the Seattle police relief and pension fund system
- 6 indicating the member's desire to make an irrevocable transfer of
- 7 credit from the Seattle system to this retirement system. The member
- 8 shall restore his or her contributions, with interest since the date of
- 9 withdrawal as determined by the director, no later than December 31,
- 10 1992.
- 11 (2) Upon receipt of the written declaration, the Seattle police
- 12 relief and pension fund system shall send the department a report of
- 13 the member's service credit. It shall also transfer to the department
- 14 the portion of such member's contributions that was retained in the
- 15 Seattle police relief and pension fund pursuant to RCW 41.20.150, plus
- 16 a sum equal to such member's total contributions to the Seattle police
- 17 relief and pension fund, which shall be treated as matching
- 18 contributions by the employer, plus the compound interest that would
- 19 have been generated by such sums, as determined by the Seattle city
- 20 treasurer. The Seattle police relief and pension fund system shall
- 21 send the service credit report and transfer the funds within ninety
- 22 days of receiving the member's written declaration.
- 23 <u>NEW SECTION.</u> **Sec. 5.** Sections 3 and 4 of this act are
- 24 necessary for the immediate preservation of the public peace, health,
- 25 or safety, or support of the state government and its existing public
- 26 institutions, and shall take effect immediately.
