- 7 The history, economy, culture, and the future of Washington state
- 8 to a large degree all involve agriculture, which is vital to the
- 9 economic well-being of the state. The legislature finds that farmers
- 10 and ranchers are responsible stewards of the land, but are increasingly
- 11 subjected to complaints and unwarranted restrictions that encourage,
- 12 and even force, the premature removal of lands from agricultural uses.
- 13 The legislature further finds that it is now in the overriding
- 14 public interest that support for agriculture be clearly expressed and

- 1 that adequate protection be given to agricultural lands, uses,
- 2 activities, and operations.
- 3 The legislature further finds that the department of agriculture
- 4 has a duty to promote and protect agriculture and its dependent rural
- 5 community in Washington state.
- 6 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 15.04 RCW

- 8 The department shall seek to enhance, protect, and perpetuate the
- 9 ability of the private sector to produce food and fiber. Additionally,
- 10 the department shall seek to maintain the economic well-being of the
- 11 agricultural industry and its dependent rural community in Washington
- 12 state.
