- 1 AN ACT Relating to state board of education size and terms; and
- 2 amending RCW 28A.305.010, 28A.305.080, and 28A.305.030.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 Sec. 1. RCW 28A.305.010 and 1990 c 33 s 257 are each amended to
- 5 read as follows:
- 6 The state board of education shall be comprised of ((two)) one
- 7 member((s)) from each congressional district of the state, not
- 8 including any congressional district at large, elected by the members
- 9 of the boards of directors of school districts thereof, as hereinafter
- 10 in this chapter provided, the superintendent of public instruction and
- 11 one member elected at large, as provided in this chapter, by the
- 12 members of the boards of directors of all private schools in the state
- 13 meeting the requirements of RCW 28A.195.010. The member representing
- 14 private schools shall not vote on matters affecting public schools. If

- 1 there is a dispute about whether or not an issue directly affects
- 2 public schools, the dispute shall be settled by a majority vote of the
- 3 other members of the board.
- 4 Sec. 2. RCW 28A.305.080 and 1990 c 33 s 263 are each amended to
- 5 read as follows:
- 6 The term of office of each member of the state board of education
- 7 shall begin on the second Monday in January next following the election
- 8 at which he or she was elected, and he or she shall hold office for the
- 9 term for which he or she was elected and until his or her successor is
- 10 elected and qualified. Except as otherwise provided in RCW
- 11 28A.305.030, each member of the state board of education shall be
- 12 elected for a term of ((six)) four years.
- 13 **Sec. 3.** RCW 28A.305.030 and 1990 c 33 s 259 are each amended to
- 14 read as follows:
- 15 (1) Whenever any new and additional congressional district is
- 16 created, except a congressional district at large, the superintendent
- 17 of public instruction shall call an election in such district at the
- 18 time of making the call provided for in RCW 28A.305.020. Such election
- 19 shall be conducted as other elections provided for in this chapter. At
- 20 the first such election ((two)) one member ((s)) of the state board of
- 21 education shall be elected((, one for a term of three years and one for
- 22 a term of six years. At the expiration of the term of each, a member
- 23 shall be elected)) for a term of ((six)) four years.
- 24 (2) The terms of office of members of the state board of education
- 25 who are elected from the various congressional districts shall not be
- 26 affected by the creation of either new or new and additional districts.
- 27 In such an event, each board member may continue to serve in office for
- 28 the balance of the term for which he or she was elected or appointed:

- 1 PROVIDED, That the board member continues to reside within the
- 2 boundaries of the congressional district as they existed at the time of
- 3 his or her election or appointment. Vacancies which occur in a board
- 4 member position during the balance of any such term shall be filled
- 5 pursuant to RCW 28A.305.090 by a successor who resides within the
- 6 boundaries of the congressional district from which the member whose
- 7 office was vacated was elected as they existed at the time of his or
- 8 her election. At the election immediately preceding expiration of the
- 9 term of office of each board member provided for in this subsection
- 10 following the creation of either new or new and additional
- 11 congressional districts, and thereafter, a successor shall be elected
- 12 from the congressional district which corresponds in number with the
- 13 congressional district from which the incumbent was appointed or
- 14 elected.
- 15 (3) Notwithstanding any other provision of this section or chapter,
- 16 <u>in order to reduce the number of state board of education members</u>
- 17 <u>elected from each congressional district from two members to one member</u>
- 18 the following transitional measures shall govern board member terms,
- 19 <u>elections</u>, and voting:
- 20 (a) The terms of office for each of the sixteen state board of
- 21 education members and positions representing the first through the
- 22 <u>eighth congressional districts shall terminate in a sequence commencing</u>
- 23 with the terms of the four members and positions representing the third
- 24 and sixth congressional districts as of the second Monday of January
- 25 <u>1993</u>, followed by the terms of the six members and positions
- 26 representing the first, fourth, and seventh congressional districts as
- 27 of the second Monday of January 1994, and ending with the termination
- 28 of the terms of the six members and positions representing the second,
- 29 fifth, and eighth congressional districts as of the second Monday of
- 30 <u>January 1995;</u>

- 1 (b) An election shall be conducted under RCW 28A.305.040 through
- 2 28A.305.060 each year preceding the termination of one or more terms
- 3 under (a) of this subsection for the purpose of electing one state
- 4 <u>board of education member from each correspondingly numbered</u>
- 5 <u>congressional district for a term of four years;</u>
- 6 (c) If for any reason a vacancy occurs in one of two positions
- 7 representing a congressional district before the termination of the
- 8 term for the position under (a) of this subsection, no replacement may
- 9 be appointed or elected and the position shall be deemed eliminated;
- 10 <u>and</u>
- 11 (d) During the transition period from the second Monday of January
- 12 1993, to the second Monday of January 1995, a vote on any matter before
- 13 the state board of education by any one of two members representing the
- 14 same congressional district shall be equal to one-half a vote and a
- 15 vote by any other member shall be equal to one full vote. Thereafter,
- 16 the vote of each member shall be equal to one full vote.
