- 5 (1) The provisions of this chapter shall not apply to any activity
- 6 in connection with services provided by a common carrier pursuant to

- 8 commission or the Federal Communication Commission and any activity of

- 10 otherwise prohibited by this law in the construction, maintenance,

- 14 any person engaged as a common carrier or public service company for
