1 AN ACT Relating to nursing homes for underserved ethnic minorities;
2 adding a new section to chapter 70.38 RCW; creating a new section; and
3 declaring an emergency.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** A new section is added to chapter 70.38 RCW
6 to read as follows:

7 (1) The legislature recognizes that in this state ethnic minorities
8 currently use nursing home care at a lower rate than the general
9 population. The legislature also recognizes and supports the federal
10 mandate that nursing homes receiving federal funds provide residents
11 with a homelike environment. The legislature finds that certain ethnic
12 minorities have special cultural, language, dietary, and other needs
13 not generally met by existing nursing homes which are intended to serve
14 the general population. Accordingly, the legislature further finds
15 that there is a need to foster the development of nursing homes

1 designed to serve the special cultural, language, dietary, and other
2 needs of ethnic minorities.

3 (2) The department shall establish a separate pool of no more than
4 two hundred fifty beds for nursing homes designed to serve the special
5 needs of ethnic minorities. The pool shall be made up of nursing home
6 beds that become available on or after March 15, 1991, due to:

7 (a) Loss of license or reduction in licensed bed capacity if the
8 beds are not otherwise obligated for replacement; or

9 (b) Expiration of a certificate of need.

10 (3) The department shall develop procedures for the fair and
11 efficient award of beds from the special pool. In making its decisions
12 regarding the award of beds from the pool, the department shall
13 consider at least the following:

14 (a) The relative degree to which the long-term care needs of an
15 ethnic minority are not otherwise being met;

16 (b) The percentage of low-income persons who would be served by the
17 proposed nursing home;

18 (c) The financial feasibility of the proposed nursing home; and

19 (d) The impact of the proposal on the area's total need for nursing
20 home beds.

21 (4) To be eligible to apply for or receive an award of beds from
22 the special pool, an application must be to build a new nursing home,
23 or add beds to a nursing home, that:

24 (a) Will be owned and operated by a nonprofit corporation, and at
25 least fifty percent of the board of directors of the corporation are
26 members of the ethnic minority the nursing home is intended to serve;

27 (b) Will be designed, managed, and administered to serve the
28 special cultural, language, dietary, and other needs of an ethnic
29 minority; and

1 (c) Will not discriminate in admissions against persons who are not
2 members of the ethnic minority whose special needs the nursing home is
3 designed to serve.

4 (5) If a nursing home or portion of a nursing home that is built as
5 a result of an award from the special pool is sold or leased within ten
6 years to a party not eligible under subsection (4) of this section:

7 (a) The purchaser or lessee may not operate those beds as nursing
8 home beds without first obtaining a certificate of need for new beds
9 under this chapter; and

10 (b) The beds that had been awarded from the special pool shall be
11 returned to the special pool.

12 (6) The department shall initially award up to one hundred beds
13 before that number of beds are actually in the special pool, provided
14 that the number of beds so awarded are subtracted from the total of two
15 hundred fifty beds that can be awarded from the special pool.

16 NEW SECTION. **Sec. 2.** This act is necessary for the immediate
17 preservation of the public peace, health, or safety, or support of the
18 state government and its existing public institutions, and shall take
19 effect immediately.

20 NEW SECTION. **Sec. 3.** If specific funding for the purposes of
21 this act, referencing this act by bill number, is not provided by June
22 30, 1991, in the omnibus appropriations act, this act shall be null and
23 void.
