Sec. 2. A new section is added to chapter 41.50 RCW 20 to read as follows: 21 (1)Retirees whose reported earnable compensation included 22 payments made pursuant to an agreement to terminate or retire, or to provide notice of intent to retire, shall not be required to repay to 23 the trust funds any overpayments resulting from the employer 24 25 misreporting, subject to the conditions provided in subsection (2) of this section. The retirees' allowances shall be prospectively adjusted 26 to reflect the benefits to which the retirees are correctly entitled. 27 (2) Subsection (1) of this section shall apply only to members of 28

the teachers' retirement system who retired prior to January 1, 1993,

from service with a community college district.

- (3) Any retirees under subsection (2) of this section who, since 1 January 1, 1990, have had their retirement allowances reduced under RCW 2 41.50.130(1)(b) because of the inclusion of retirement agreement 3 4 payments in calculating their allowances, shall have their allowances 5 adjusted to reflect the benefits to which the retirees are correctly entitled, but without a reduction to recoup prior overpayments. 6 retirees shall be reimbursed by their employers for the cumulative 8 amount of the reduction in their retirement allowance that has occurred 9 since January 1, 1990, to recoup prior overpayments.
- (4) Any retirees covered by subsection (2) of this section who, after January 1, 1990, repaid a previous overpayment in a lump sum under RCW 41.50.130(1)(b) because of the inclusion of retirement agreement payments in calculating their allowances, shall be reimbursed by their employers for the amount of the lump sum repayment.
- 15 (5) The employers of retirees affected by this section shall be 16 billed by the department for the costs incurred by the trust funds due 17 to the inclusion of retirement agreement payments in calculating 18 retiree benefits. The billings shall be calculated and administered in 19 a manner consistent with the provisions of RCW 41.50.150."
- 20 <u>EFFECT:</u> TRS members who retired from community colleges before January 1, 1993 and who had "retirement incentives" included in the calculation of their pensions, will have their pensions adjusted prospectively only to reflect their correct allowance, and will not be required to repay prior overpayments. The employer will be billed for the costs to the pension funds of any previous overpayments caused by the retirement incentives.
- Anyone whose pension was reduced after January 1, 1990, to reflect previous overpayments will get a new pension calculation that does not reflect repayment of previous overpayments, and will be reimbursed by their employer for the reduction that has already occurred. Anyone who repaid previous overpayments in a lump sum will be reimbursed by their employer for the repayment.

On page 2, after line 6, insert the following:

NEW SECTION. Sec. 2. A new section is added to chapter 41.50 RCW to read as follows:

3 Members of the teachers' retirement system who retired prior to 4 January 1, 1993, from service with a community college district whose reported earnable compensation included payments made pursuant to an 5 agreement to terminate or retire, or to provide notice of intent to 6 retire, and whose retirement allowance has been reduced under RCW 7 8 41.50.150 or is reduced after the effective date of this act under 9 section (1) of this act, shall have an opportunity to change the retirement allowance payment option selected by the member under RCW 10 41.32.530. Any request for a change shall be made in writing to the 11 department no later than October 31, 1993 and shall apply prospectively 12 13 only."

14 <u>EFFECT:</u> TRS I members who retired from community colleges before 15 January 1, 1993 and who had, or will have, their pensions reduced 16 by the department because the pensions included "retirement 17 incentives," may change their retirement payment option by October 18 31, 1993.
