- 1 AN ACT Relating to public works contracts; and amending RCW
- 2 28A.335.190, 35.22.620, 35.23.352, 36.32.250, 39.04.015, and 39.04.155.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 28A.335.190 and 1990 c 33 s 362 are each amended to 5 read as follows:
- 6 read as follows:
 6 (1) When, in the opinion of the board of directors of any school
- 7 district, the cost of any furniture, supplies, equipment, building,
- 8 improvements, or repairs, or other work or purchases, except books,
- 9 will equal or exceed the sum of twenty thousand dollars, complete plans
- 10 and specifications for such work or purchases shall be prepared and
- 11 notice by publication given in at least one newspaper of general
- 12 circulation within the district, once each week for two consecutive
- 13 weeks, of the intention to receive bids therefor and that
- 14 specifications and other information may be examined at the office of
- 15 the board or any other officially designated location: PROVIDED, That
- 16 the board without giving such notice may make improvements or repairs
- 17 to the property of the district through the shop and repair department
- 18 of such district when the total of such improvements or repair does not
- 19 exceed the sum of seventy-five hundred dollars. The cost of any public

- work, improvement or repair for the purposes of this section shall be the aggregate of all amounts to be paid for labor, material, and equipment on one continuous or interrelated project where work is to be performed simultaneously or in close sequence. The bids shall be in writing and shall be opened and read in public on the date and in the place named in the notice and after being opened shall be filed for public inspection.
 - (2) Every purchase of furniture, equipment or supplies, except books, the cost of which is estimated to be in excess of seventy-five hundred dollars, shall be on a competitive basis. The board of directors shall establish a procedure for securing telephone and/or written quotations for such purchases. Whenever the estimated cost is from seventy-five hundred dollars up to twenty thousand dollars, the procedure shall require quotations from at least three different sources to be obtained in writing or by telephone, and recorded for public perusal. Whenever the estimated cost is in excess of twenty thousand dollars, the public bidding process provided in subsection (1) of this section shall be followed.
 - (3) Every building, improvement, repair or other public works project, the cost of which is estimated to be in excess of seventy-five hundred dollars, shall be on a competitive bid process. All such projects estimated to be less than twenty thousand dollars may be awarded to a contractor on the small works roster. The small works roster shall be comprised of all responsible contractors who have requested to be on the list. The board of directors shall establish a procedure for securing telephone and/or written quotations from the contractors on the small works roster to assure establishment of a competitive price and for awarding contracts to the lowest responsible bidder, except as provided in subsection (5) of this section. procedure shall require that a good faith effort be made to request quotations from all contractors on the small works roster who have indicated the capability of performing the kind of public works being Immediately after an award is made, the bid quotations contracted. obtained shall be recorded, open to public inspection, and available by telephone inquiry. The small works roster shall be revised at least once each year by publishing notice of such opportunity in at least one newspaper of general circulation in the district. Responsible contractors shall be added to the list at any time they submit a written request. Whenever the estimated cost of a public works project

- is twenty thousand dollars or more, the public bidding process provided in subsection (1) of this section shall be followed.
- (4) The contract for the ((work or)) purchase shall be awarded to the lowest responsible bidder as defined in RCW 43.19.1911 but the board may by resolution reject any and all bids and make further calls for bids in the same manner as the original call. On any ((work or)) purchase the board shall provide bidding information to any qualified bidder or the bidder's agent, requesting it in person.
- (5) For public works, the contract shall be awarded to a contractor that can meet its financial obligations, can demonstrate its ability to produce a quality project, shows its ability to participate in a state-approved apprentice program, and has demonstrated its ability to comply with all laws pertaining to minority and female hiring and affirmative action, but the board may by resolution reject any and all bids and make further calls for bids in the same manner as the original call. On any work the board shall provide bidding information to any qualified bidder or the bidder's agent, requesting it in person.

- (6) In the event of any emergency when the public interest or property of the district would suffer material injury or damage by delay, upon resolution of the board declaring the existence of such an emergency and reciting the facts constituting the same, the board may waive the requirements of this section with reference to any purchase or contract: PROVIDED, That an "emergency", for the purposes of this section, means a condition likely to result in immediate physical injury to persons or to property of the school district in the absence of prompt remedial action.
- **Sec. 2.** RCW 35.22.620 and 1989 c 431 s 59 are each amended to read 28 as follows:
- 29 (1) As used in this section, the term "public works" means as 30 defined in RCW 39.04.010.
 - (2) A first class city may have public works performed by contract pursuant to public notice and call for competitive bids. As limited by subsection (3) of this section, a first class city may have public works performed by city employees in any annual or biennial budget period equal to a dollar value not exceeding ten percent of the public works construction budget, including any amount in a supplemental public works construction budget, over the budget period. The amount of public works that a first class city has a county perform for it

1 under RCW 35.77.020 shall be included within this ten percent 2 limitation.

3 If a first class city has public works performed by public 4 employees in any budget period that are in excess of this ten percent limitation, the amount in excess of the permitted amount shall be 5 reduced from the otherwise permitted amount of public works that may be 6 7 performed by public employees for that city in its next budget period. 8 Twenty percent of the motor vehicle fuel tax distributions to that city 9 shall be withheld if two years after the year in which the excess 10 amount of work occurred, the city has failed to so reduce the amount of public works that it has performed by public employees. The amount so 11 12 withheld shall be distributed to the city when it has demonstrated in 13 its reports to the state auditor that the amount of public works it has performed by public employees has been so reduced. 14

Whenever a first class city has had public works performed in any budget period up to the maximum permitted amount for that budget period, all remaining public works within that budget period shall be done by contract pursuant to public notice and call for competitive bids.

The state auditor shall report to the state treasurer any first class city that exceeds this amount and the extent to which the city has or has not reduced the amount of public works it has performed by public employees in subsequent years.

24 (3) In addition to the percentage limitation provided in subsection 25 (2) of this section, a first class city with a population in excess of 26 one hundred fifty thousand shall not have public employees perform a public works project in excess of fifty thousand dollars if more than 27 a single craft or trade is involved with the public works project, or 28 a public works project in excess of twenty-five thousand dollars if 29 30 only a single craft or trade is involved with the public works project or the public works project is street signalization or street lighting. 31 In addition to the percentage limitation provided in subsection (2) of 32 33 this section, a first class city with a population of one hundred fifty 34 thousand or less shall not have public employees perform a public works 35 project in excess of thirty-five thousand dollars if more than one craft or trade is involved with the public works project, or a public 36 37 works project in excess of twenty thousand dollars if only a single craft or trade is involved with the public works project or the public 38 39 works project is street signalization or street lighting. - 5 (4) In addition to the accounting and record-keeping requirements contained in RCW 39.04.070, every first class city annually shall 6 7 prepare a report for the state auditor indicating the total public 8 works construction budget and supplemental public works construction 9 budget for that year, the total construction costs of public works performed by public employees for that year, and the amount of public works that is performed by public employees above or below ten percent of the total construction budget. However, if a city budgets on a 12 13 biennial basis, this annual report shall indicate the amount of public works that is performed by public employees within the current biennial period that is above or below ten percent of the total biennial 16 construction budget.
- 17 After September 1, 1987, each first class city with a population of one hundred fifty thousand or less shall use the form required by RCW 18 19 43.09.205 to account and record costs of public works in excess of five thousand dollars that are not let by contract. 20
- (5) The cost of a separate public works project shall be the costs 21 of materials, supplies, equipment, and labor on the construction of 22 23 that project. The value of the public works budget shall be the value 24 of all the separate public works projects within the budget.
- 25 (6) When any emergency shall require the immediate execution of 26 such public work, upon the finding of the existence of such emergency by the authority having power to direct such public work to be done and 27 duly entered of record, publication of description and estimate may be 28 made within seven days after the commencement of the work. Within two 29 30 weeks of the finding that such an emergency existed, the city council 31 shall adopt a resolution certifying the existence of this emergency situation. 32
- (7) In lieu of the procedures of subsections (2) and (6) of this 33 34 section, a first class city may use a small works roster and award 35 contracts under this subsection for contracts of one hundred thousand dollars or less. 36
- 37 (a) The city may maintain a small works roster comprised of all contractors who have requested to be on the roster and are, where 38

- (b) Whenever work is done by contract, the estimated cost of which 3 4 is one hundred thousand dollars or less, and the city uses the small 5 works roster, the city shall invite proposals from all appropriate contractors on the small works roster: PROVIDED, That not less than 6 five separate appropriate contractors, if available, shall be invited 7 to submit bids on any one contract: PROVIDED FURTHER, That whenever 8 9 possible, the city shall invite at least one proposal from a minority 10 or woman contractor who shall otherwise qualify under this section. Once a bidder on the small works roster has been offered an opportunity 11 12 to bid, that bidder shall not be offered another opportunity until all 13 other appropriate contractors on the small works roster have been afforded an opportunity to submit a bid. Invitations shall include an 14 15 estimate of the scope and nature of the work to be performed, and materials and equipment to be furnished. 16
 - (c) When awarding such a contract for work, the estimated cost of which is one hundred thousand dollars or less, the city shall award the contract to ((the)) a contractor ((submitting the lowest responsible bid)) that can meet its financial obligations, can demonstrate its ability to produce a quality project, shows its ability to participate in a state-approved apprentice program, and has demonstrated its ability to comply with all laws pertaining to minority and female hiring and affirmative action.
- 25 (8) The allocation of public works projects to be performed by city 26 employees shall not be subject to a collective bargaining agreement.
- (9) This section does not apply to performance-based contracts, as defined in RCW 39.35A.020(3), that are negotiated under chapter 39.35A RCW.
- 30 (10) Nothing in this section shall prohibit any first class city 31 from allowing for preferential purchase of products made from recycled 32 materials or products that may be recycled or reused.
- 33 **Sec. 3.** RCW 35.23.352 and 1989 c 431 s 56 are each amended to read as follows:
- 35 (1) Any second or third class city or any town may construct any 36 public works, as defined in RCW 39.04.010, by contract or day labor 37 without calling for bids therefor whenever the estimated cost of the 38 work or improvement, including cost of materials, supplies and

Whenever the cost of the public work or improvement, including materials, supplies and equipment, will exceed these figures, the same shall be done by contract. All such contracts shall be let at public bidding upon posting notice calling for sealed bids upon the work. The notice thereof shall be posted in a public place in the city or town and by publication in the official newspaper, or a newspaper of general circulation most likely to bring responsive bids, once each week for two consecutive weeks before the date fixed for opening the bids. notice shall generally state the nature of the work to be done that plans and specifications therefor shall then be on file in the city or town hall for public inspections, and require that bids be sealed and filed with the council or commission within the time specified therein. Each bid shall be accompanied by a bid proposal deposit in the form of a cashier's check, postal money order, or surety bond to the council or commission for a sum of not less than five percent of the amount of the bid, and no bid shall be considered unless accompanied by such bid proposal deposit. The council or commission of the city or town shall let the contract to ((the lowest responsible)) a bidder that can meet its financial obligations, can demonstrate its ability to produce a quality project, shows its ability to participate in a state-approved apprentice program or has demonstrated its ability to comply with all laws pertaining to minority and female hiring and affirmative action, or shall have power by resolution to reject any or all bids and to make further calls for bids in the same manner as the original call.

When the contract is let then all bid proposal deposits shall be returned to the bidders except that of the successful bidder which shall be retained until a contract is entered into and a bond to perform the work furnished, with surety satisfactory to the council or commission, in the full amount of the contract price. If the bidder fails to enter into the contract in accordance with his bid and furnish a bond within ten days from the date at which he is notified that he is

Immediately after the award 20 is made, the bid quotations obtained shall be recorded and open to public inspection and shall be available by telephone inquiry. 21
- (9) These requirements for purchasing may be waived by resolution of the city or town council which declared that the purchase is clearly and legitimately limited to a single source or supply within the near vicinity, or the materials, supplies, equipment, or services are subject to special market conditions, and recites why this situation exists. Such actions are subject to RCW 39.30.020.
- (10) This section does not apply to performance-based contracts, as defined in RCW 39.35A.020(3), that are negotiated under chapter 39.35A RCW.
- 31 (11) Nothing in this section shall prohibit any second or third 32 class city or any town from allowing for preferential purchase of 33 products made from recycled materials or products that may be recycled 34 or reused.
- 35 **Sec. 4.** RCW 36.32.250 and 1991 c 363 s 58 are each amended to read as follows:
- No contract for public works may be entered into by the county legislative authority or by any elected or appointed officer of the

An advertisement shall also be 10 published in a legal newspaper of general circulation in or as near as possible to that part of the county in which such work is to be done. 11 12 If the county official newspaper is a newspaper of general circulation 13 covering at least forty percent of the residences in that part of the county in which such public works are to be done, then the publication 14 15 of an advertisement of the applicable specifications in the county 16 official newspaper shall be sufficient. - (1) This section provides a uniform process to award contracts for public works projects by those counties that are authorized to use a small works roster in lieu of the requirements for formal sealed bidding. The state statutes governing counties shall establish the maximum dollar thresholds of the contracts that can be awarded under this process, and may include other matters concerning the small works roster process, for the county.
- 10 (2) Counties may create a single general small works roster, or may create a small works roster for different categories of anticipated 11 The small works roster or rosters shall consist of all 12 work. 13 responsible contractors who have requested to be on the list, and where required by law are properly licensed or registered to perform such 14 work in this state. At least once a year, the county shall publish in 15 16 a newspaper of general circulation within the jurisdiction a notice of 17 the existence of the roster or rosters and solicit the names of contractors for such roster or rosters. 18

19 The governing body of the county shall establish a procedure for 20 securing telephone or written quotations from the contractors on the general small works roster, or a specific small works roster for the 21 appropriate category of work, to assure that a competitive price is 22 23 established and to award contracts to ((the lowest responsible)) a 24 bidder((, as defined in RCW 43.19.1911)) that can meet its financial 25 obligations, can demonstrate its ability to produce a quality project, 26 shows its ability to participate in a state-approved apprentice program, and has demonstrated its ability to comply with all laws 27 pertaining to minority and female hiring and affirmative action. Such 28 29 invitations for quotations shall include an estimate of the scope and 30 nature of the work to be performed as well as materials and equipment 31 to be furnished. Whenever possible at least five contractors shall be invited to submit bids. Once a contractor has been afforded an 32 opportunity to submit a proposal, that contractor shall not be offered 33 34 another opportunity until all other appropriate contractors on the 35 small works roster have been afforded an opportunity to submit a proposal on a contract. 36

A contract awarded from a small works roster under this section 38 need not be advertised.
