- 1 AN ACT Relating to agricultural products; adding new sections to
- 2 chapter 70.95C RCW; and making an appropriation.

- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** (1) The legislature finds that the disposal
- 5 of packaging materials imposes costs and environmental hazards to the
 - state and the region. At the same time, the state of Washington is a
- 7 major producer of wheat and peas, two products that make an excellent
- 8 source of biodegradable plastics. Perfecting the technology for
- 9 transforming wheat and peas into biodegradable plastics would benefit
- 10 the state's consumers and ecology and would increase the sale and use
- 11 of these products that are grown in many rural counties.
- 12 (2) Washington State University shall undertake the research
- 13 necessary to perfect the technology needed to transform wheat and peas
- 14 into appropriate plastic packaging materials. This will involve three
- 15 primary steps: (a) Developing effective fractionation processes to
- 16 break the wheat and peas into their usable components, (b) developing
- 17 the technology for transforming the starch components into plastics,
- 18 and (c) finding economic uses for the glutens, dietary fibers, and

- $1\,$ other components, so the manufacturing of the entire grain or legume
- 2 can be done at breakeven cost or above.
- 3 NEW SECTION. Sec. 2. (1) The legislature finds that there are
- 4 opportunities to develop technologies for grain and legume processing
- 5 that can help consumers, the environment, and rural communities of the
- 6 state of Washington. Without assistance from the state, these
- 7 technologies cannot be brought to the point where private sector
- 8 commercialization and application can take place.
- 9 (2) Washington State University shall develop and execute a plan to
- 10 address systematically the current obstacles to development and
- 11 commercialization of biodegradable plastics from wheat and legumes.
- 12 <u>NEW SECTION.</u> **Sec. 3.** Sections 1 and 2 of this act are each added
- 13 to chapter 70.95C RCW.
- 14 <u>NEW SECTION.</u> **Sec. 4.** (1) The sum of two hundred thousand dollars,
- 15 or as much thereof as may be necessary, is appropriated for the
- 16 biennium ending June 30, 1995, from the general fund to Washington
- 17 State University to carry out the purposes of section 1 of this act.
- 18 (2) Washington State University shall make every effort to secure
- 19 nonstate matching support for these activities.
