- 1 AN ACT Relating to urban wildlife management areas; adding a new
- 2 section to chapter 77.12 RCW; and creating a new section.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that areas of the
- 5 state of Washington hold significant importance for wildlife habitat,
- 6 study, and recreation. Those areas located near major urban areas and
- 7 important research institutions possess unique potential for study and
- 8 research into the development, management, and use of natural systems
- 9 in urban environments.
- 10 It is the intent of the legislature to protect and enhance these
- 11 areas for the following purposes:
- 12 (1) Use as wildlife habitat;
- 13 (2) Application of rational practices for the management of
- 14 biological systems in urban environments;
- 15 (3) Biological, environmental, and landscape architectural research
- 16 and teaching;
- 17 (4) Recreational enjoyment of nature that is compatible with the
- 18 environment; and

- 1 (5) Protection from development or construction other than that 2 necessary to accomplish the purposes listed in this section.
- 3 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 77.12 RCW 4 to read as follows:
- 5 (1) The Union Bay portion of Lake Washington is recognized as a 6 prime wetland area that is of significant importance for wildlife 7 habitat, educational opportunity, and recreation. It is also situated 8 near an important research institution, the University of Washington.
- 9 (2) By December 31, 1994, the department shall develop a management 10 plan for the Union Bay-Ravenna Creek cooperative wildlife habitat 11 management area. The plan shall:
- 12 (a) Identify the boundaries of the Union Bay-Ravenna Creek 13 cooperative wildlife habitat management area;
- 14 (b) Suggest methods of restoring the Union Bay-Ravenna Creek 15 watershed to a more natural state, such as daylighting Ravenna Creek;
- 16 (c) Identify wildlife resources of, wildlife management objectives 17 for, and compatible uses with wildlife in the Union Bay-Ravenna Creek 18 cooperative wildlife habitat management area;
- 19 (d) Present a strategy for accomplishing the wildlife objectives; 20 and
- 21 (e) Identify appropriate environmental education opportunities for 22 the area.
- (3) The department shall establish advisory committees to provide technical assistance and policy guidance. Membership on the committees shall include but not be limited to persons representing the interests of federal, state, and local governmental entities, Indian tribes, relevant property owners and community members, business, and the environmental community.
- 29 (4) By December 31, 1993, the department shall provide a progress 30 report to the house of representatives fisheries and wildlife committee 31 and the senate committee on parks and ecology.
- 32 (5) The department may solicit gifts, grants, conveyances, 33 bequests, and devises, whether real or personal property, or both, in 34 trust or otherwise, to be directed to the department for carrying out 35 the purposes of this section. The department may solicit contracts for 36 work, financial and in-kind contributions, and support from private
