- 8 (1) It is unlawful for any person under the age of twenty-one years
- 9 to be in a public place while under the influence of or affected by
- 10 intoxicating liquor or any drug, or the combined influence of or
- 11 affected by intoxicating liquor and any drug.
- 12 (2) This section does not apply to liquor or a drug given for
- 13 medicinal purposes to a person under the age of twenty-one years by, or
- 14 under the direction of, a physician or dentist.
- 15 (3) This section does not apply to liquor given to a person under
- 16 the age of twenty-one years when such liquor is being used in

- (4) Enforcement of this section by a law enforcement officer may be 1 accomplished only as a secondary action when the law enforcement 2 3 officer has a reasonable suspicion:
- 4 (a) The person under the age of twenty-one years is committing or has committed an offense under the laws of the state of Washington or 5 local ordinance, other than under this section, RCW 46.61.688, or any 6 other law or ordinance creating an offense as a secondary action; or 7
- 8 (b) The actions of the person under the age of twenty-one years 9 constitute a danger to persons or property.
- (5) Conviction or forfeiture of bail for a violation of this 10 section by a person under the age of twenty-one years at the time of 11 such conviction or forfeiture shall not be a disqualification of that 12 person to acquire a license to sell or dispense any liquor or drug 13 after that person has attained the age of twenty-one years. 14
