- 1 AN ACT Relating to prohibiting interference with access to health
- 2 care, health care providers, and health care service delivery; adding
- 3 a new chapter to Title 9A RCW; creating a new section; and prescribing
- 4 penalties.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 NEW SECTION. Sec. 1. The legislature finds that seeking or
- 7 obtaining health care is fundamental to public health and safety.
- 8 NEW SECTION. Sec. 2. (1) "Health care facility" means a facility
- 9 that provides health care services directly to patients, including but
- 10 not limited to, a hospital, clinic, health care provider's office,
- 11 health maintenance organization, diagnostic or treatment center,
- 12 neuropsychiatric or mental health facility, hospice, or nursing home.
- 13 (2) "Health care provider" has the same meaning as defined in RCW
- 14 7.70.020 (1) and (2), and also means an officer, director, employee, or
- 15 agent of a health care facility who sues or testifies regarding matters
- 16 within the scope of his or her employment.

- NEW SECTION. Sec. 3. It is unlawful for a person, alone or in concert with others, to willfully or recklessly interfere with access to or from a health care facility or willfully or recklessly disrupt the normal functioning of such facility by:
- 5 (1) Physically obstructing or impeding the free passage of a person 6 seeking to enter or depart from the facility or from the common areas 7 of the real property upon which the facility is located;
- 8 (2) Making noise that unreasonably disturbs the peace within the 9 facility;
- 10 (3) Trespassing on the facility or the common areas of the real 11 property upon which the facility is located;
- 12 (4) Telephoning the facility in violation of RCW 9.61.230; or
- 13 (5) Threatening to inflict injury on the owners, agents, patients,
- 14 employees, or property of the facility or knowingly permitting any
- 15 telephone under his or her control to be used for such purpose.
- 16 <u>NEW SECTION.</u> **Sec. 4.** A violation of section 3 of this act is a 17 gross misdemeanor.
- 18 <u>NEW SECTION.</u> **Sec. 5.** A person or health care facility aggrieved
- 19 by the actions prohibited by section 3 of this act may seek civil
- 20 damages from those who committed the prohibited acts and those acting
- 21 in concert with them. A plaintiff in an action brought under this
- 22 chapter shall not recover more than his or her actual damages, costs
- 23 and attorneys' fees. A person does not have to be criminally convicted
- 24 of violating section 3 of this act to be held civilly liable under this
- 25 section.
- 26 <u>NEW SECTION.</u> **Sec. 6.** Section 3 of this act shall not be
- 27 interpreted to apply to the actions of any agent, officer, or employee
- 28 of the health care facility, acting within the scope of his or her
- 29 agency, office, or employment, nor to the actions of any law
- 30 enforcement officer, acting within the scope of his or her agency.
- 31 <u>NEW SECTION.</u> **Sec. 7.** A court having jurisdiction over a criminal
- 32 or civil proceeding under this chapter shall take all steps reasonably
- 33 necessary to safeguard the individual privacy and prevent harassment of
- 34 a health care patient or health care provider who is a party or witness
- 35 in a proceeding, including granting protective orders and orders in

- 1 limine. In civil actions brought under this chapter, upon showing of
- 2 good cause, the court may permit health care patients to sue
- 3 pseudonymously.
- 4 <u>NEW SECTION.</u> **Sec. 8.** Nothing in this chapter shall be construed
- 5 to limit the right to seek other available criminal or civil remedies.
- 6 The remedies provided in this chapter are cumulative, not exclusive.
- 7 <u>NEW SECTION.</u> **Sec. 9.** If any provision of this act or its
- 8 application to any person or circumstance is held invalid, the
- 9 remainder of the act or the application of the provision to other
- 10 persons or circumstances is not affected.
- 11 <u>NEW SECTION.</u> **Sec. 10.** Sections 2 through 8 of this act shall
- 12 constitute a new chapter in Title 9A RCW.
