- 1 AN ACT Relating to appropriations based on revenue received; adding
- 2 a new section to chapter 43.88 RCW; creating new sections; and
- 3 declaring an emergency.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that state government
- 6 is funded by taxpayers who work hard to provide for themselves, their
- 7 families, their occupations, and their businesses. These persons must
- 8 exercise fiscal responsibility in order to meet their needs and yet
- 9 live within their means according to the incomes they receive. The
- 10 legislature further finds that basing appropriations on forecasts of
- 11 future revenues has driven government spending higher and higher and
- 12 created the need for more and more taxes.
- 13 The citizens of Washington state have a right to expect state
- 14 government to live within its means; to eliminate waste in government
- 15 programs and agencies; to provide efficient, cost-effective services;
- 16 to establish spending priorities and planning; to ensure balanced
- 17 budgets without imposing new taxes and other costs on taxpayers; and to
- 18 make appropriations based more closely on the revenues they will
- 19 actually receive.

- 1 Therefore, the legislature declares there is a substantial public
- 2 purpose in protecting taxpayers by ensuring state government is
- 3 fiscally responsible. To accomplish this purpose, it is the intent of
- 4 the legislature to require state government to make budgets and
- 5 appropriations based more closely on revenues it actually received
- 6 rather than on forecast of future revenues.
- 7 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 43.88 RCW
- 8 to read as follows:
- 9 All state appropriations shall be based on revenues actually
- 10 received during the second previous quarter. As an example, total
- 11 appropriations for the July through September quarter may not exceed
- 12 total revenues actually received from the previous January through
- 13 March quarter, and so forth accordingly.
- 14 <u>NEW SECTION.</u> **Sec. 3.** This act may be known and cited as "the
- 15 government budget and appropriation accountability act."
- 16 <u>NEW SECTION.</u> **Sec. 4.** If any provision of this act or its
- 17 application to any person or circumstance is held invalid, the
- 18 remainder of the act or the application of the provision to other
- 19 persons or circumstances is not affected.
- 20 <u>NEW SECTION.</u> **Sec. 5.** This act is necessary for the immediate
- 21 preservation of the public peace, health, or safety, or support of the
- 22 state government and its existing public institutions, and shall take
- 23 effect immediately.
