- 1 AN ACT Relating to periodic adjustments of the state minimum wage;
- 2 amending RCW 49.46.020; providing an effective date; and declaring an
- 3 emergency.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 49.46.020 and 1989 c 1 s 2 are each amended to read as 6 follows:
- 7 (1) Every employer shall pay to each of his or her employees who
- 8 has reached the age of eighteen years wages at a rate of not less than
- 9 ((three dollars and eighty-five cents per hour except as may be
- 10 otherwise provided under this section. Beginning January 1, 1990, the
- 11 state minimum wage shall be)) four dollars and twenty-five cents per
- 12 hour, except that the wage rate shall be:
- 13 (a) Beginning on July 1, 1993, four dollars and ninety cents per
- 14 hour;
- 15 (b) Beginning on July 1, 1994, and readjusted beginning on each
- 16 July 1 thereafter, adjusted from the amount specified in (a) of this
- 17 <u>subsection to the nearest cent which bears the ratio of its original</u>
- 18 amount which is found to exist between the index for 1992 and the index
- 19 for the calendar year prior to the year of adjustment. For the

- 1 purposes of this subsection "index" means, for any calendar year, that
- 2 year's annual average consumer price index for Seattle-Everett
- 3 <u>metropolitan statistical area urban wage earners and clerical workers,</u>
- 4 <u>all items (1957-1959) compiled by the bureau of labor statistics,</u>
- 5 <u>United States department of labor</u>.
- 6 (2) The director shall by regulation establish the minimum wage for
- 7 employees under the age of eighteen years.
- 8 NEW SECTION. Sec. 2. This act is necessary for the immediate
- 9 preservation of the public peace, health, or safety, or support of the
- 10 state government and its existing public institutions, and shall take
- 11 effect July 1, 1993.
