State of Washington 53rd Legislature 1993 Regular Session

Read first time 01/27/93. Referred to Committee on Commerce & Labor.

- 1 AN ACT Relating to cemetery fees, funeral directors and embalmers
- 2 account created; amending RCW 68.05.100, 68.05.205, and 18.39.290; and
- 3 adding a new section to chapter 18.39 RCW.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 68.05.100 and 1987 c 331 s 9 are each amended to read 6 as follows:
- 7 The board may establish necessary rules and regulations for the
- 8 enforcement of this title and the laws subject to its jurisdiction and
- 9 prescribe the form of statements and reports provided for in this
- 10 title. Rules regulating the cremation of human remains and
- 11 establishing ((fees and)) permit requirements shall be adopted in
- 12 consultation with the state board of funeral directors and embalmers.
- 13 **Sec. 2.** RCW 68.05.205 and 1987 c 331 s 16 are each amended to read
- 14 as follows:
- 15 ((Every cemetery authority shall pay for each cemetery operated by
- 16 it, an annual regulatory charge to be fixed by the director of not more
- 17 than three dollars per interment, entombment, and inurnment made during
- 18 the preceding full calendar year, which charges shall be deposited in

- 1 the cemetery account. Upon payment of said charges and compliance with
- 2 the provisions of Title 68 RCW and the lawful orders, rules, and
- 3 regulations of the board, the board will issue a certificate of
- 4 authority.)) The director with the consent of the cemetery board shall
- 5 set all fees for chapters 68.05, 68.20, 68.24, 68.28, 68.32, 68.36,
- 6 <u>68.40</u>, 68.44, and 68.46 RCW in accordance with RCW 43.24.086 including
- 7 fees for licenses, certificates, regulatory charges, permits, or
- 8 <u>endorsements and the department shall collect the fees, the fees to be</u>
- 9 deposited in the cemetery account.
- 10 **Sec. 3.** RCW 18.39.290 and 1986 c 259 s 69 are each amended to read 11 as follows:
- 12 All certificates of registration issued pursuant to this chapter
- 13 shall continue in force until the expiration date unless suspended or
- 14 revoked. A certificate shall be subject to renewal annually ninety
- 15 days after the end of its fiscal year, as stated on the original
- 16 application, by the funeral establishment and payment of the required
- 17 fees.

- 18 The director shall determine and collect fees related to
- 19 certificate of registration licensure in accordance with RCW 43.24.086.
- 20 All fees so collected shall be remitted by the director to the
- 21 state treasurer not later than the first business day following receipt
- 22 of such funds and the funds shall be credited to the ((health
- 23 professions)) funeral directors and embalmers account.
- NEW SECTION. Sec. 4. A new section is added to chapter 18.39 RCW
- 25 to read as follows:
- 26 The funeral directors and embalmers account is created in the
- 27 custody of the state treasurer. All fees received by the department
- 28 for licenses, registrations, renewals, examinations, and audits shall
- 29 be forwarded to the state treasurer who shall credit the money to the

account. All fines and civil penalties ordered by the superior court

- 31 or fines ordered under RCW 18.130.160(8) against holders of licenses or
- 32 registrations issued under the provisions of this chapter shall be paid
- 33 to the account. All expenses incurred in carrying out the licensing
- 34 and registration activities of the department and the state funeral
- 35 directors and embalmers board under this chapter shall be paid from the
- 36 account as authorized by legislative appropriation. Any residue in the
- 37 account shall be accumulated and shall not revert to the general fund

- 1 at the end of the biennium. All earnings of investments of balances in
- 2 the account shall be credited to the general fund. A fund balance
- 3 remaining in the health professions account attributable to the funeral
- 4 director and embalmer professions as of the effective date of this act
- 5 shall be transferred to the funeral directors and embalmers account.
