- 1 AN ACT Relating to the economic development finance authority;
- 2 amending RCW 43.163.070, 43.163.090, and 43.163.901; and repealing RCW
- 3 43.163.005, 43.163.010, 43.163.020, 43.163.030, 43.163.040, 43.163.050,
- 4 43.163.060, 43.163.070, 43.163.080, 43.163.090, 43.163.100, 43.163.110,

- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 8 **Sec. 1.** RCW 43.163.070 and 1990 c 53 s 4 are each amended to read 9 as follows:
- 10 The authority may use any funds legally available to it for any
- 11 purpose specifically authorized by this chapter, or for otherwise
- 12 improving economic development in this state by assisting businesses
- 13 and farm enterprises that do not have access to capital at terms and
- 14 rates comparable to large corporations due to the location of the
- 15 business, the size of the business, the lack of financial expertise, or
- 16 other appropriate reasons: PROVIDED, That no funds of the state shall
- 17 be used for such purposes and that loans made to persons, firms, or
- 18 entities shall not exceed five million dollars per borrower or per

- 1 project. The programs authorized by this chapter shall emphasize
- 2 <u>assistance to small businesses and women and minority-owned businesses</u>.
- 3 **Sec. 2.** RCW 43.163.090 and 1989 c 279 s 10 are each amended to 4 read as follows:
- The authority shall adopt a general plan of economic development finance objectives to be implemented by the authority during the period of the plan. The authority may exercise the powers authorized under this chapter prior to the adoption of the initial plan. In developing the plan, the authority shall consider and set objectives for:
- 10 (1) Employment generation associated with the authority's programs;
- 11 (2) The application of funds to sectors and regions of the state 12 economy evidencing need for improved access to capital markets and 13 funding resources;
- 14 (3) Geographic distribution of funds and programs available through 15 the authority;
- 16 (4) Eligibility criteria for participants in authority programs;
- 17 (5) The use of funds and resources available from or through 18 federal, state, local, and private sources and programs;
- 19 (6) Standards for economic viability and growth opportunities of 20 participants in authority programs;
- 21 (7) New programs which serve a targeted need for financing 22 assistance within the purposes of this chapter; and
- 23 (8) Opportunities to improve capital access as evidenced by 24 programs existent in other states or as they are made possible by 25 results of private capital market circumstances.

At least one public hearing shall be conducted by the authority on 26 the plan, and updates to the plan, prior to its adoption. The plan 27 shall be adopted by resolution of the authority no later than November 28 29 15, 1990. The plan shall be submitted to the chief clerk of the house of representatives and secretary of the senate for transmittal to and 30 review by the appropriate standing committees no later than December 31 15, 1990, and each December 15 thereafter. 32 The authority shall 33 ((periodically)) update the plan ((as determined necessary by the 34 authority, but not less than once every two years)) annually. The plan or updated plan shall include a report on authority activities 35 36 conducted since the commencement of authority operation or since the last plan was reported, whichever is more recent, including a statement 37 of results achieved under the purposes of this chapter and the plan. 38
