## HOUSE BILL 2233

- 1 AN ACT Relating to studded tires; amending RCW 46.37.420 and
- 2 47.36.250; and providing an effective date.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 46.37.420 and 1990 c 105 s 1 are each amended to read 5 as follows:
- 6 (1) It is unlawful to operate a vehicle upon the public highways of
  7 this state unless it is completely equipped with pneumatic rubber tires
  8 except vehicles equipped with temporary-use spare tires that meet
  9 federal standards that are installed and used in accordance with the
  10 manufacturer's instructions.
- 11 (2) No tire on a vehicle moved on a highway may have on its 12 periphery any block, flange, cleat, or spike or any other protuberance 13 of any material other than rubber which projects beyond the tread of 14 the traction surface of the tire, except that it is permissible to use 15 farm machinery with tires having protuberances that will not injure the highway, and except also that it is permissible to use tire chains or 16 17 metal studs imbedded within the tire of reasonable proportions and of a type conforming to rules adopted by the state patrol, upon any 18 19 vehicle when required for safety because of snow, ice, or other

- 1 conditions tending to cause a vehicle to skid. It is unlawful to use
- 2 metal studs imbedded within the tire between April 1st and November 1st
- 3 anywhere in the state, and it is unlawful to use studded tires west of
- 4 the crest of the Cascade mountain range at any time other than when it
- 5 is snowing or the majority of the roadway is covered by snow or ice.
- 6 The state department of transportation may, from time to time,
- 7 determine additional periods in which the use of tires with metal studs
- 8 imbedded therein is lawful.
- 9 (3) The state department of transportation and local authorities in
- 10 their respective jurisdictions may issue special permits authorizing
- 11 the operation upon a highway of traction engines or tractors having
- 12 movable tracks with transverse corrugations upon the periphery of the
- 13 movable tracks or farm tractors or other farm machinery, the operation
- 14 of which upon a highway would otherwise be prohibited under this
- 15 section.
- 16 (4) Tires with metal studs imbedded therein may be used between
- 17 November 1st and April 1st upon school buses and fire department
- 18 vehicles, any law or regulation to the contrary notwithstanding.
- 19 **Sec. 2.** RCW 47.36.250 and 1987 c 330 s 747 are each amended to
- 20 read as follows:
- 21 If the department or its delegate determines at any time for any
- 22 part of the public highway system that the unsafe conditions of the
- 23 roadway require particular tires, tire chains, or traction equipment in
- 24 addition to or beyond the ordinary pneumatic rubber tires, the
- 25 department may establish the following recommendations or requirements
- 26 with respect to the use of such equipment for all persons using such
- 27 public highway:
- 28 (1) Dangerous road conditions, chains or other approved traction
- 29 devices recommended.
- 30 (2) Dangerous road conditions, chains or other approved traction
- 31 devices required.
- 32 (3) Dangerous road conditions, chains required.
- 33 Any equipment that may be required by this section shall be
- 34 approved by the state patrol as authorized under RCW 46.37.420.
- 35 The department shall place and maintain signs and other traffic
- 36 control devices on the public highways that indicate the tire, tire
- 37 chain, or traction equipment recommendation or requirement determined
- 38 under this section. Such signs or traffic control devices shall in no

- 1 event prohibit the use of studded tires from November 1st to April
- 2 1st((, but when)) in any part of the state east of the crest of the
- 3 Cascade mountain range, or when it is snowing or a majority of the
- 4 roadway is covered by snow or ice west of the Cascade crest. If the
- 5 department determines that chains are required and that no other
- 6 traction equipment will suffice, the requirement is applicable to all
- 7 types of tires including studded tires. The signs or traffic control
- 8 devices may specify different recommendations or requirements for four
- 9 wheel drive vehicles in gear.
- 10 Failure to obey a requirement indicated by a sign or other traffic
- 11 control device placed or maintained under this section is a
- 12 misdemeanor.
- 13 <u>NEW SECTION.</u> **Sec. 3.** This act takes effect July 1, 1996.
