- At the sole discretion of the council of a city or town, a city or town may implement a system of processing permit applications where an applicant may pay the city or town an additional amount beyond the normal permit fees for the city or town to hire temporary staff, or pay overtime costs for existing staff, to review and process the permit application more expeditiously than is possible with existing staffing
