- AN ACT Relating to competing proposals for city and town annexations and incorporations; amending RCW 36.93.115; adding a new section to chapter 35.02 RCW; adding a new section to chapter 35.13 RCW; adding a new section to chapter 35A.14 RCW; and repealing RCW 35.13.175 and 35A.14.230.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- NEW SECTION. **Sec. 1.** A new section is added to chapter 35.02 RCW to read as follows:
- 9 For a period of ninety days after a petition proposing the 10 incorporation of a city or town is filed with the county auditor, a 11 petition or resolution proposing the annexation of any portion of the
- 12 territory included in the incorporation proposal may be filed or
- 13 adopted and the proposed annexation may continue following the
- 14 applicable statutory procedure. Territory that ultimately is annexed,
- 15 as a result of the filing of such an annexation petition or adoption of
- 16 such an annexation resolution during this ninety-day period, shall be
- 17 withdrawn from the incorporation proposal.
- 18 A proposed annexation of a portion of the territory included within
- 19 the proposed incorporation, that is initiated by the filing of an

annexation petition or adoption of an annexation resolution after this 1 2 ninety-day period, shall be held in abeyance and may not occur unless: (1) The boundary review board modifies the boundaries of the proposed 3 4 incorporation and removes the territory from the incorporation; (2) the boundary review board rejects the proposed 5 incorporation and the proposed city or town has a population of less 6 7 than seven thousand five hundred; (3) voters defeat the ballot 8 proposition authorizing the proposed incorporation; or (4) a boundary 9 review board simultaneously considers the proposed incorporation and the proposed annexation of the territory, as provided in RCW 36.93.115. 10

NEW SECTION. Sec. 2. A new section is added to chapter 35.13 RCW to read as follows:

After a petition proposing an annexation by a city or town is filed 13 14 with the city or town or the governing body of the city or town, or 15 after a resolution proposing an annexation by a city or town has been adopted by the city or town governing body, no territory included in 16 17 the proposed annexation may be annexed by another city or town or 18 incorporated into a city or town unless: (1) The boundary review board 19 modifies the boundaries of the proposed annexation and removes the territory; (2) the boundary review board or review board created under 20 21 RCW 35.13.171 rejects the proposed annexation; or (3) the city or town 22 governing body rejects the proposed annexation or voters defeat the 23 ballot proposition authorizing the annexation.

NEW SECTION. **Sec. 3.** A new section is added to chapter 35A.14 RCW to read as follows:

After a petition proposing an annexation by a code city has been 26 27 filed with the city or the city legislative authority, or after a 28 resolution proposing the annexation by a code city has been adopted by 29 the city legislative authority, no territory included in the proposed 30 annexation may be annexed by another city or town or incorporated into 31 a city or town unless: (1) The boundary review board or county 32 annexation review board created under RCW 35A.14.160 modifies the 33 boundaries of the proposed annexation and removes the territory; (2) the boundary review board or county annexation review board created 34 35 under RCW 35A.14.160 rejects the proposed annexation; or (3) the city legislative authority rejects the proposed annexation or voters defeat 36 37 the ballot proposition authorizing the annexation.

- 1 **Sec. 4.** RCW 36.93.115 and 1982 c 220 s 5 are each amended to read 2 as follows:
- A boundary review board((, county auditor, county legislative
- 4 authority, or any other public official or body)) may simultaneously
- 5 consider the proposed incorporation of a city or town, and the proposed
- 6 annexation of a portion of the territory included in the proposed
- 7 incorporation, if the resolution or petition initiating the annexation
- 8 is adopted or filed ninety or fewer days after the petition proposing
- 9 the incorporation was filed, and may act upon ((a petition for)) the
- 10 proposed annexation before ((considering or)) acting upon ((a)) the
- 11 petition for incorporation ((which embraces some or all of the same
- 12 territory,)) without regard to priority of filing.
- 13 <u>NEW SECTION.</u> **Sec. 5.** The following acts or parts of acts are each
- 14 repealed:
- 15 (1) RCW 35.13.175 and 1973 1st ex.s. c 164 s 18 & 1965 c 7 s
- 16 35.13.175; and
- 17 (2) RCW 35A.14.230 and 1967 ex.s. c 119 s 35A.14.230.
