- 1 AN ACT Relating to persons rendering aid who had contact with the
- 2 blood of an injured person; amending RCW 4.24.310; and adding a new
- 3 section to chapter 4.24 RCW.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 4.24 RCW 6 to read as follows:
- 7 If any person, including but not limited to a volunteer provider of
- 8 emergency or medical services, who without compensation or the
- 9 expectation of compensation renders emergency care at the scene of an
- 10 emergency or who participates in transporting, not for compensation,
- 11 therefrom an injured person or persons for emergency medical treatment,
- 12 had contact with the blood of an injured person provided aid by the
- 13 person rendering aid, the injured person shall submit to blood tests to
- 14 determine the presence of any blood-borne disease conducted by or under
- 15 quidelines adopted by the department of health. The person conducting
- 16 the blood tests or the department of health shall notify the person
- 17 rendering aid of the test results.

- Sec. 2. RCW 4.24.310 and 1989 c 223 s 1 are each amended to read as follows:
- For the purposes of RCW 4.24.300 <u>and section 1 of this act</u> the following words and phrases shall have the following meanings unless the context clearly requires otherwise:
- (1) "Compensation" has its ordinary meaning but does not include: 6 7 Nominal payments, reimbursement for expenses, or pension benefits; 8 payments made to volunteer part-time and volunteer on-call personnel of 9 departments, fire districts, ambulance districts, 10 departments, or any emergency response organizations; or any payment to a person employed as a transit operator who is paid for his or her 11 regular work, which work does not routinely include providing emergency 12 13 care or emergency transportation.
- 14 (2) "Emergency care" means care, first aid, treatment, or 15 assistance rendered to the injured person in need of immediate medical 16 attention and includes providing or arranging for further medical 17 treatment or care for the injured person. Except with respect to the 18 injured person or persons being transported for further medical 19 treatment or care, the immunity granted by RCW 4.24.300 does not apply 20 to the negligent operation of any motor vehicle.
- 21 (3) "Scene of an emergency" means the scene of an accident or other 22 sudden or unexpected event or combination of circumstances which calls 23 for immediate action.
