- 1 AN ACT Relating to the student-teacher-employer-parent partnership
- 2 act; creating a new section; and declaring an emergency.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** The legislature recognizes the importance of
- 5 both education and employment experiences for the youth of this state.
- 6 In addition, the legislature recognizes that improved approaches to
- 7 moving youth from educational experiences to employment is critical for
- 8 their successful transition to the work force, that encouraging and
- 9 developing partnerships between youth, their parents, employers, and
- 10 teachers to provide realistic work experiences that enhance the
- 11 student's educational experience are necessary to support these
- 12 objectives, that the role of schools must be complementary to these
- 13 objectives without imposing requirements that distract from the
- 14 school's primary role as educational institutions, and that educational
- 15 and parenting decisions should be further supported by minor work rules
- 16 that establish minimum reasonable parameters for youth employment.
