1 AN ACT Relating to delaying implementation of 1993 health care  
2 reform; adding a new section to chapter 41.05 RCW; adding a new section  
3 to chapter 28A.400 RCW; adding a new section to chapter 74.09 RCW;  
4 adding a new section to chapter 19.68 RCW; adding a new section to  
5 chapter 82.32 RCW; adding a new section to chapter 43.20 RCW; adding a  
6 new section to chapter 70.170 RCW; adding a new section to chapter  
7 70.41 RCW; adding a new section to chapter 18.64 RCW; adding a new  
8 section to chapter 18.51 RCW; adding a new section to chapter 28B.125  
9 RCW; adding a new section to chapter 70.185 RCW; adding a new section  
10 to chapter 43.70 RCW; adding a new section to chapter 48.01 RCW; adding  
11 a new section to chapter 66.08 RCW; adding a new section to chapter

15 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

16 NEW SECTION. **Sec. 1.** A new section is added to chapter 41.05 RCW  
17 to read as follows:

18 The state health care authority shall delay implementation of the  
19 Washington health services act of 1993, chapter 492, Laws of 1993,

1 except for the duties of the health care authority under chapter 70.47  
2 RCW, until July 1, 1994.

3 NEW SECTION. **Sec. 2.** A new section is added to chapter 28A.400  
4 RCW to read as follows:

19        NEW SECTION.    **Sec. 21.**    This act is necessary for the immediate  
20 preservation of the public peace, health, or safety, or support of the  
21 state government and its existing public institutions, and shall take  
22 effect immediately.
