- 1 AN ACT Relating to state government; adding a new section to
- 2 chapter 44.04 RCW; and creating a new section.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds and declares that it
- 5 is now possible and feasible in this electronic age to more widely
- 6 distribute legislative information by way of electronic communication
- 7 in order to better inform the public of the matters pending before the
- 8 legislature and its proceedings. The legislature further finds that it
- 9 is desirable to make information regarding these matters and
- 10 proceedings available to the citizens of this state, irrespective of
- 11 where they reside, in a timely manner and for the least possible cost.
- 12 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 44.04 RCW
- 13 to read as follows:
- 14 (1) The chief clerk of the house of representatives and the
- 15 secretary of the senate shall make all of the following information
- 16 available to the public in electronic form:
- 17 (a) The legislative calendar, the schedule of legislative committee
- 18 hearings, a list of matters pending on the floors of both houses of the

- 1 legislature, and a list of the committees of the legislature and their
 2 members;
- 3 (b) The text of each bill introduced in each current legislative 4 session, including each amended, enrolled, and session law form of each 5 bill;
- 6 (c) The legislative history of each bill introduced and amended in each current legislative session;
- 8 (d) The bill status of each bill introduced and amended in each 9 current legislative session;
- 10 (e) All bill reports prepared by legislative committees in 11 connection with each bill in each current legislative session;
- 12 (f) All vote information concerning each bill in each current 13 legislative session;
- 14 (g) Any veto message concerning a bill in each current legislative 15 session;
- 16 (h) The Washington State Constitution; and
- 17 (i) All statutes enacted on or after January 1, 1994.
- (2) The information identified in subsection (1) of this section 18 19 shall be made available to the public in one or more formats and by one 20 or more means in order to provide the greatest feasible access to the general public in this state. Any person who accesses the information 21 may access all or any part of the information. 22 The information may also be made available by any other means of access that would 23 24 facilitate public access to the information. The information that is 25 maintained in the legislative information system that is operated and 26 maintained by the legislature shall be made available in the shortest feasible time after the information is available in the information 27 The information that is not maintained in the information 28 29 system shall be made available in the shortest feasible time after it 30 is available to the chief clerk of the house of representatives and the secretary of the senate. 31
- 32 (3) The electronic digital format of the information identified in 33 subsection (1) of this section must be ASCII US text.
- 34 (4) Personal information concerning a person who accesses the 35 information may be maintained only for the purpose of providing service 36 to the person.
- 37 (5) The state may not impose a fee or other charge as a condition 38 of accessing the information identified in subsection (1) of this 39 section.
