- 2 TO THE WASHINGTON STATE TRANSPORTATION COMMISSION, AND TO THE
- 3 WASHINGTON STATE DEPARTMENT OF TRANSPORTATION:
- 4 We, your Memorialists, the Senate and House of Representatives of
- 5 the State of Washington, in legislative session assembled, respectfully
- 6 represent and petition as follows:
- 7 WHEREAS, Homer M. Hadley was an innovative engineer who worked to
- 8 expand transportation access to the east side of Lake Washington in the
- 9 1920's and 1930's; and
- 10 WHEREAS, His idea to design and construct a concrete floating
- 11 bridge across Lake Washington conquered every technological challenge
- 12 of the day; and
- 13 WHEREAS, Despite skepticism and opposition, he supplied the
- 14 engineering feasibility study for a floating bridge across Lake
- 15 Washington; and
- 16 WHEREAS, His surveying skills, engineering expertise, and
- 17 perseverance made possible the eventual siting and construction of the
- 18 world's first concrete floating bridge; and
- 19 WHEREAS, Homer M. Hadley has not been formally recognized for his
- 20 contribution and leadership in making the floating bridge a reality;

- 1 WHEREAS, The third Lake Washington bridge, located on Interstate
- 2 90, is currently unnamed; and
- 3 WHEREAS, It is most appropriate for the third Lake Washington
- 4 bridge, located on Interstate 90, to be named the Homer M. Hadley
- 5 Memorial Bridge;
- 6 NOW, THEREFORE, BE IT RESOLVED, That the Senate and House of
- 7 Representatives of the state of Washington recognize, praise, and honor
- 8 Homer M. Hadley for his far-reaching contribution to the citizens and
- 9 the transportation system of Washington State; and
- 10 NOW, THEREFORE, Your Memorialists respectfully pray that the
- 11 Washington State Transportation Commission commence proceedings to name
- 12 the newly constructed bridge the Homer M. Hadley Memorial Bridge; and

- 15 Transportation, the Washington State Transportation commission, and the
