1            AN ACT Relating to jurisdiction over certain roads and highways;  
2 amending RCW 47.17.001, 47.17.305, 47.17.577, 47.39.020, 47.42.020,  
3 47.42.100, and 47.42.140; adding new sections to chapter 47.17 RCW;  
4 adding a new section to chapter 47.39 RCW; creating a new section; and  
5 repealing RCW 47.17.565.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7            **Sec. 1.** RCW 47.17.001 and 1990 c 233 s 1 are each amended to read  
8 as follows:

9            In considering whether to make additions, deletions, or other  
10 changes to the state highway system, the legislature shall be guided by  
11 the following criteria as contained in the Road Jurisdiction Committee  
12 Phase I report to the legislature dated January 1987:

13            (1) A rural highway route should be designated as a state highway  
14 if it meets any of the following criteria:

15            (a) Is designated as part of the national system of interstate and  
16 defense highways (popularly called the interstate system); or

17            (b) Is designated as part of the system of numbered United States  
18 routes; or

1 (c) Contains an international border crossing that is open twelve  
2 or more hours each day.

3 (2) A rural highway route may be designated as a state highway if  
4 it is part of an integrated system of roads and:

5 (a) Carries in excess of three hundred thousand tons annually and  
6 provides primary access to a rural port or intermodal freight terminal;

7 (b) Provides a major cross-connection between existing state  
8 highways; (~~or~~)

9 (c) Connects places exhibiting one or more of the following  
10 characteristics:

11 (i) A population center of one thousand or greater;

12 (ii) An area or aggregation of areas having a population  
13 equivalency of one thousand or more, such as, but not limited to,  
14 recreation areas, military installations, and so forth;

15 (iii) A county seat;

16 (iv) A major commercial-industrial terminal in a rural area with a  
17 population equivalency of one thousand or greater; or

18 (d) Is designated as a scenic and recreational highway.

19 (3) An urban highway route that meets any of the following criteria  
20 should be designated as part of the state highway system:

21 (a) Is designated as part of the interstate system;

22 (b) Is designated as part of the system of numbered United States  
23 routes;

24 (c) Is an urban extension of a rural state highway into or through  
25 an urban area and is necessary to form an integrated system of state  
26 highways;

27 (d) Is a principal arterial that is a connecting link between two  
28 state highways and serves regionally oriented through traffic in  
29 urbanized areas with a population of fifty thousand or greater, or is  
30 a spur that serves regionally oriented traffic in urbanized areas.

31 (4) The following guidelines are intended to be used as a basis for  
32 interpreting and applying the criteria to specific routes:

33 (a) For any route wholly within one or more contiguous  
34 jurisdictions which would be proposed for transfer to the state highway  
35 system under these criteria, if local officials prefer, responsibility  
36 will remain at the local level.

37 (b) State highway routes maintain continuity of the system by being  
38 composed of routes that join other state routes at both ends or to

1 arterial routes in the states of Oregon and Idaho and the Province of  
2 British Columbia.

3 (c) Public facilities may be considered to be served if they are  
4 within approximately two miles of a state highway.

5 (d) Exceptions may be made to include:

6 (i) Rural spurs as state highways if they meet the criteria  
7 relative to serving population centers of one thousand or greater  
8 population or activity centers with population equivalencies or an  
9 aggregated population of one thousand or greater;

10 (ii) Urban spurs as state highways that provide needed access to  
11 Washington state ferry terminals, state parks, major seaports, and  
12 trunk airports; and

13 (iii) Urban connecting links as state highways that function as  
14 needed bypass routing of regionally oriented through traffic and  
15 benefit truck routing, capacity alternative, business congestion, and  
16 geometric deficiencies.

17 (e) In urban and urbanized areas:

18 (i) Unless they are significant regional traffic generators, public  
19 facilities such as state hospitals, state correction centers, state  
20 universities, ferry terminals, and military bases do not constitute a  
21 criteria for establishment of a state highway; and

22 (ii) There may be no more than one parallel nonaccess controlled  
23 facility in the same corridor as a freeway or limited access facility  
24 as designated by the metropolitan planning organization.

25 (f) When there is a choice of two or more routes between population  
26 centers, the state route designation shall normally be based on the  
27 following considerations:

28 (i) The ability to handle higher traffic volumes;

29 (ii) The higher ability to accommodate further development or  
30 expansion along the existing alignment;

31 (iii) The most direct route and the lowest travel time;

32 (iv) The route that serves traffic with the most interstate, state-  
33 wide, and interregional significance;

34 (v) The route that provides the optimal spacing between other state  
35 routes; and

36 (vi) The route that best serves the comprehensive plan for  
37 community development in those areas where such a plan has been  
38 developed and adopted.

1        (g) A route designated in chapter 47.39 RCW as a scenic and  
2 recreational highway may be designated as a state highway in addition  
3 to a parallel state highway route.

4        **Sec. 2.** RCW 47.17.305 and 1970 ex.s. c 51 s 62 are each amended to  
5 read as follows:

6        A state highway to be known as state route number 160 is  
7 established as follows:

8        Beginning at a junction with state route number 16 in the vicinity  
9 ~~((west))~~ south of Port Orchard, thence ~~((northeasterly by way of Port~~  
10 ~~Orchard to Harper and))~~ easterly on Sedgwick Road to the Washington  
11 state ferry dock at Point Southworth.

12        NEW SECTION. **Sec. 3.** A new section is added to chapter 47.17 RCW  
13 to read as follows:

14        A state highway to be known as state route number 166 is  
15 established as follows:

16        Beginning at a junction with state route number 16 in the vicinity  
17 west of Port Orchard, thence northeasterly to the eastern Port Orchard  
18 city limits.

23        Beginning at a junction with state route number 3 in Bremerton,

23 transportation shall place high priority on obtaining funds from those  
24 sources for further development of a scenic and recreational highways  
25 program, including highway heritage projects on the designated scenic  
26 and recreational highway system. The department shall consider the use  
27 of the designated system by bicyclists and pedestrians in connection  
28 with nonmotorized routes in the state trail plan, and the state bicycle  
29 plan which are also eligible for ISTEPA funding. Appropriate signage  
30 may be used at intersections of nonmotorized and motorized systems to  
31 demonstrate the access, location, and the interconnectivity of various  
32 modes of travel for transportation and recreation.

33       NEW SECTION. Sec. 9. A new section is added to chapter 47.39 RCW  
34 to read as follows:

35       In developing the scenic and recreational highways program, the  
36 department shall consult with the department of trade and economic  
37 development, the department of community development, the department of

1 natural resources, the parks and recreation commission, affected  
2 cities, towns, and counties, regional transportation planning  
3 organizations, state-wide bicycling organizations, and other interested  
4 parties. The scenic and recreational highways program may identify  
5 entire highway loops or similar tourist routes that could be developed  
6 to promote tourist activity and provide concurrent economic growth  
7 while protecting the scenic and recreational quality surrounding state  
8 highways.

19 become part of the national system of interstate and defense highways

29 park, federal forest area, public beach, public recreation area, or  
30 national monument, (b) any state highway or portion thereof outside the  
31 boundaries of any incorporated city or town designated by the  
32 legislature as a part of the scenic system, or (c) any state highway or  
33 portion thereof outside the boundaries of any incorporated city or town  
34 designated by the legislature as a part of the scenic and recreational  
35 highway system except for the sections of highways specifically  
36 excluded in RCW 47.42.025 or located within areas zoned by the  
37 governing county for predominantly commercial and industrial uses, and

1 having development visible to the highway, as determined by the  
2 department.

3 (8) "Sign" means any outdoor sign, display, device, figure,  
4 painting, drawing, message, placard, poster, billboard, or other thing  
5 that is designed, intended, or used to advertise or inform, any part of  
6 the advertising or informative contents of which is visible from any  
7 place on the main-traveled way of the interstate system or other state  
8 highway.

9 (9) "Commercial and industrial areas" means any area zoned  
10 commercial or industrial by a county or municipal code, or if unzoned  
11 or zoned for general uses by a county or municipal code, that area  
12 occupied by three or more separate and distinct commercial or  
13 industrial activities, or any combination thereof, within a space of  
14 five hundred feet and the area within five hundred feet of such  
15 activities on both sides of the highway. The area shall be measured  
16 from the outer edges of the regularly used buildings, parking lots, or  
17 storage or processing areas of the commercial or industrial activity  
18 and not from the property lines of the parcels upon which the  
19 activities are located. Measurements shall be along or parallel to the  
20 edge of the main traveled way of the highway. The following shall not  
21 be considered commercial or industrial activities:

22 (a) Agricultural, forestry, grazing, farming, and related  
23 activities, including, but not limited to, wayside fresh produce  
24 stands;

25 (b) Transient or temporary activities;

26 (c) Railroad tracks and minor sidings;

28 (e) Activities more than six hundred and sixty feet from the

32 If any commercial or industrial activity that has been used in defining  
33 or delineating an unzoned area ceases to operate for a period of six  
34 continuous months, any signs located within the former unzoned area

36 (10) "Roadside area information panel or display" means a panel or  
37 display located so as not to be readable from the main traveled way,  
38 erected in a safety rest area, scenic overlook, or similar roadside

1 area, for providing motorists with information in the specific interest  
2 of the traveling public.

3 (11) "Temporary agricultural directional sign" means a sign on  
4 private property adjacent to state highway right of way to provide  
5 directional information to places of business offering for sale  
6 seasonal agricultural products on the property where the sale is taking  
7 place.

10 (1) No sign lawfully erected in a protected area as defined by
