1            WHEREAS, Bills, joint resolutions, joint memorials, and concurrent  
2 resolutions introduced at the 1994 regular session of the Fifty-third  
3 Legislature may require that they be considered at the 1994 first  
4 special session of the Fifty-third Legislature; and

5            WHEREAS, The public interest requires that the business of the 1994  
6 first special session of the Fifty-third Legislature be considered and  
7 acted upon as efficiently and expeditiously as possible;

8            NOW, THEREFORE, BE IT RESOLVED, By the House of Representatives,  
9 the Senate concurring, That all bills not in conference on adjournment  
10 SINE DIE of the 1994 regular session, joint resolutions, joint  
11 memorials, and concurrent resolutions introduced in the 1994 regular  
12 session of the Fifty-third Legislature are reintroduced in the house in  
13 which they originated and shall retain the same number and be given the  
14 highest legislative status that they attained in the original house as  
15 shown by the official House of Representatives and Senate dockets upon  
16 the adjournment SINE DIE of the regular session; and

17            BE IT FURTHER RESOLVED, That House of Representatives bills in  
18 conference on adjournment SINE DIE of the 1994 regular session for  
19 which a conference report has been distributed to the desks of both  
20 House of Representatives and Senate members for at least twenty-four  
21 hours prior to convening of the special session shall be reintroduced

1 in conference status in the Senate and be eligible for adoption of the  
2 conference report, and, if the Senate adopts the conference report and  
3 passes the bill on final passage, shall be reintroduced in the House of  
4 Representatives eligible for adoption of the conference report and  
5 final passage; and

6 BE IT FURTHER RESOLVED, That Senate bills in conference on  
7 adjournment SINE DIE of the 1994 regular session for which a conference  
8 report has been distributed to the desks of both House of  
9 Representatives and Senate members for at least twenty-four hours prior  
10 to convening of the special session shall be reintroduced in that  
11 status in the House of Representatives and be eligible for adoption of  
12 the conference report, and, if the House of Representatives adopts the  
13 conference report and passes the bill on final passage, shall be  
14 reintroduced in the Senate in conference status and be eligible for  
15 adoption of the conference report and final passage; and

16 BE IT FURTHER RESOLVED, That House of Representatives bills in  
17 conference on adjournment SINE DIE of the 1994 regular session for  
18 which a conference report has not been distributed to the desks of both  
19 House of Representatives and Senate members for at least twenty-four  
20 hours prior to convening of the special session shall be reintroduced  
21 in conference status in the Senate, and, if the Senate adopts a  
22 conference report and passes the bill on final passage, shall be  
23 reintroduced in conference status in the House of Representatives; and

24 BE IT FURTHER RESOLVED, That Senate bills in conference on  
25 adjournment SINE DIE of the 1994 regular session for which a conference  
26 report has not been distributed to the desks of both House of  
27 Representatives and Senate members for at least twenty-four hours prior  
28 to convening of the special session shall be reintroduced in conference  
29 status in the House of Representatives, and, if the House of  
30 Representatives adopts a conference report and passes the bill on final  
31 passage, shall be reintroduced in conference status in the Senate; and

32 BE IT FURTHER RESOLVED, That no bill shall be transmitted to the  
33 governor unless during this first special session the bill has passed  
34 both houses on final passage.
