- 4 Sec. 1. RCW 85.22.010 and 1933 c 182 s 1 are each amended to read 5 as follows:
- 6 Any diking district ((<del>organized under the provisions of chapter</del>
- 7 CXVII (117) of the Laws of 1895, and the acts amendatory thereof, which
- 8 has been reorganized under the provisions of chapter 131 of the Laws of
- 9 1917, and the acts amendatory thereof, and any)); drainage district
- 10 ((organized under the provisions of chapter CXV (115) of the Laws of
- 11 1895, and the acts amendatory thereof, whether the same has been
- 12 organized as a drainage and irrigation improvement district or as a
- 13 drainage district; intercounty diking and
- 14 <u>drainage district; diking, drainage, and/or sewerage improvement</u>
- 15 <u>district; consolidated diking district, drainage district, diking</u>
- 16 <u>improvement district</u>, <u>and/or drainage improvement district</u>; <u>or flood</u>
- 17 control district may reorganize as a drainage and irrigation

NEW SECTION. Sec. 2. A new section is added to chapter 85.38 RCW to read as follows:

A special district may withdraw area from its boundaries that is located within the boundaries of a city or town, or area that includes area both within and adjacent to the boundaries of any city or town, under this section.

- 7 (1) The withdrawal of area is authorized upon the following 8 conditions being met: (a) Adoption of a resolution by the special 9 district requesting withdrawal of the area from the district; (b) adoption of a resolution by the city or town council approving the 10 withdrawal of the special district from the area; (c) assumption by the 11 city or town of full responsibility for the maintenance, improvements, 12 and collection of payment for the operation of the system previously 13 operated by the special district in the area; (d) transfer by the 14 15 special district of all rights-of-way or easements in the area to the city or town by quit claim or deed; and (e) adoption of an interlocal 16 agreement between the special district and the city or town that 17 reimburses the special district for lost assessment revenue from the 18 19 withdrawn area, that transfers any facilities or improvements owned by 20 the special district to the city or town as agreed between the parties, and that requires the city or town to maintain existing water run-off 21 and water quality levels in the area. 22
  - (2) Property in the territory withdrawn from the boundaries of a special district under this section shall remain liable for any special assessments of the special district from which it was withdrawn, if the special assessments are associated with bonds or notes used to finance facilities serving the property, to the same extent as if the withdrawal of property had not occurred.
- 29 <u>NEW SECTION.</u> **Sec. 3.** RCW 85.07.080 and 1983 c 167 s 191 and 1935 30 c 103 s 3 are each repealed.
