1 AN ACT Relating to bidding practices of municipalities; and
2 amending RCW 39.04.155, 39.04.190, 39.04.200, 39.30.045, 36.32.240,
3 36.32.253, 36.32.245, 36.32.250, 35.22.620, 35.23.352, 52.14.110,
4 52.14.120, 53.08.120, 54.04.070, 54.04.082, 56.08.070, 56.08.080,
5 56.08.090, 57.08.015, 57.08.016, 57.08.050, and 70.44.140.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 **Sec. 1.** RCW 39.04.155 and 1991 c 363 s 109 are each amended to
8 read as follows:

9 (1) This section provides a uniform process to award contracts for
10 public works projects by those ((counties)) municipalities that are
11 authorized to use a small works roster in lieu of the requirements for
12 formal sealed bidding. The state statutes governing ((counties)) a
13 specific type of municipality shall establish the maximum dollar
14 thresholds of the contracts that can be awarded under this process, and
15 may include other matters concerning the small works roster process,
16 for the ((county)) municipality.

17 (2) ((Counties)) Such municipalities may create a single general
18 small works roster, or may create a small works roster for different
19 categories of anticipated work. The small works roster or rosters

1 shall consist of all responsible contractors who have requested to be
2 on the list, and where required by law are properly licensed or
3 registered to perform such work in this state. At least ((~~once~~)) twice
4 a year, the ((~~county~~)) municipality shall publish in a newspaper of
5 general circulation within the jurisdiction a notice of the existence
6 of the roster or rosters and solicit the names of contractors for such
7 roster or rosters.

8 The governing body of the ((~~county~~)) municipality shall establish
9 a procedure for securing telephone or written quotations from the
10 contractors on the general small works roster, or a specific small
11 works roster for the appropriate category of work, to assure that a
12 competitive price is established and to award contracts to the lowest
13 responsible bidder, as defined in RCW 43.19.1911. Such invitations for
14 quotations shall include an estimate of the scope and nature of the
15 work to be performed as well as materials and equipment to be
16 furnished. Whenever possible at least five contractors shall be
17 invited to submit bids. Once a contractor has been afforded an
18 opportunity to submit a proposal, that contractor shall not be offered
19 another opportunity until all other appropriate contractors on the
20 small works roster have been afforded an opportunity to submit a
21 proposal on a contract. Proposals may be invited from all appropriate
22 contractors on the small works roster.

23 A contract awarded from a small works roster under this section
24 need not be advertised.

25 Immediately after an award is made, the bid quotations obtained
26 shall be recorded, open to public inspection, and available by
27 telephone inquiry.

28 **Sec. 2.** RCW 39.04.190 and 1991 c 363 s 110 are each amended to
29 read as follows:

30 (1) This section provides a uniform process to award contracts for
31 the purchase of any materials, equipment, supplies, or services by
32 those ((~~counties~~)) municipalities that are authorized to use this
33 process in lieu of the requirements for formal sealed bidding. The
34 state statutes governing ((~~counties~~)) a specific type of municipality
35 shall establish the maximum dollar thresholds of the contracts that can
36 be awarded under this process, and may include other matters concerning
37 the awarding of contracts for purchases, for the ((~~county~~))
38 municipality.

1 (2) At least (~~once~~) twice per year, the (~~county~~) municipality
2 shall publish in a newspaper of general circulation within the
3 jurisdiction a notice of the existence of vendor lists and solicit the
4 names of vendors for the lists. (~~Counties~~) Municipalities shall by
5 resolution establish a procedure for securing telephone or written
6 quotations, or both, from at least three different vendors whenever
7 possible to assure that a competitive price is established and for
8 awarding the contracts for the purchase of any materials, equipment,
9 supplies, or services to the lowest responsible bidder as defined in
10 RCW 43.19.1911. Immediately after the award is made, the bid quotations
11 obtained shall be recorded, open to public inspection, and shall be
12 available by telephone inquiry. A contract awarded pursuant to this
13 section need not be advertised.

14 **Sec. 3.** RCW 39.04.200 and 1991 c 363 s 111 are each amended to
15 read as follows:

16 Any (~~county~~) municipality that utilizes the small works roster
17 process established in RCW 39.04.155 to award contracts for public
18 works projects, or the uniform process established in RCW 39.04.190 to
19 award contracts for purchases, must post a list of the contracts
20 awarded under RCW 39.04.155 and 39.04.190 at least once every two
21 months. The list shall contain the name of the contractor or vendor
22 awarded the contract, the amount of the contract, a brief description
23 of the type of work performed or items purchased under the contract,
24 and the date it was awarded. The list shall also state the location
25 where the bid quotations for these contracts are available for public
26 inspection.

27 **Sec. 4.** RCW 39.30.045 and 1991 c 363 s 112 are each amended to
28 read as follows:

29 Any (~~county~~) municipality, as defined in RCW 39.04.010, may
30 purchase any supplies, equipment, or materials at auctions conducted by
31 the government of the United States or any agency thereof, any agency
32 of the state of Washington, any municipality or other government
33 agency, or any private party without being subject to public bidding
34 requirements if the items can be obtained at a competitive price.

35 **Sec. 5.** RCW 36.32.240 and 1991 c 363 s 57 are each amended to read
36 as follows:

1 In any county the county legislative authority may by resolution
2 establish a county purchasing department. The purchasing department
3 shall contract on a competitive basis for all public works, enter into
4 leases of personal property on a competitive basis, and purchase all
5 supplies, materials, and equipment, on a competitive basis, for all
6 departments of the county, as provided in this chapter and chapter
7 39.04 RCW, except that the county purchasing department is not required
8 to make purchases for the county hospital, or make purchases that are
9 paid from the county road fund or equipment rental and revolving fund.

10 **Sec. 6.** RCW 36.32.253 and 1991 c 363 s 63 are each amended to read
11 as follows:

12 No lease of personal property may be entered into by the county
13 legislative authority or by any elected or appointed officer of the
14 county (~~until after bids have been submitted to the county. The~~
15 ~~county shall use the same~~) except upon use of the procedures specified
16 in (~~(RCW 36.32.245 and 39.04.190)~~) this chapter and chapter 39.04 RCW
17 for awarding contracts for purchases when it leases property from the
18 lowest responsible bidder.

19 **Sec. 7.** RCW 36.32.245 and 1991 c 363 s 62 are each amended to read
20 as follows:

21 (1) No contract for the purchase of materials, equipment, supplies,
22 or services may be entered into by the county legislative authority or
23 by any elected or appointed officer of the county until after bids have
24 been submitted to the county. Bid specifications shall be in writing
25 and shall be filed with the clerk of the county legislative authority
26 for public inspection. An advertisement shall be published in the
27 official newspaper of the county stating the time and place where bids
28 will be opened, the time after which bids will not be received, the
29 materials, equipment, supplies, or services to be purchased, and that
30 the specifications may be seen at the office of the clerk of the county
31 legislative authority. The advertisement shall be published at least
32 once at least (~~(ten)~~) thirteen days prior to the last date upon which
33 bids will be received.

34 (2) The bids shall be in writing and filed with the clerk. The
35 bids shall be opened and read in public at the time and place named in
36 the advertisement. Contracts requiring competitive bidding under this
37 section may be awarded only to the lowest responsible bidder.

1 Immediately after the award is made, the bid quotations shall be
2 recorded and open to public inspection and shall be available by
3 telephone inquiry. Any or all bids may be rejected for good cause.

4 (3) For advertisement and formal sealed bidding to be dispensed
5 with as to purchases between two thousand five hundred and twenty-five
6 thousand dollars, the county legislative authority must use the uniform
7 process to award contracts as provided in RCW 39.04.190. Advertisement
8 and formal sealed bidding may be dispensed with as to purchases of less
9 than two thousand five hundred dollars upon the order of the county
10 legislative authority.

11 (4) This section does not apply to performance-based contracts, as
12 defined in RCW 39.35A.020(3), that are negotiated under chapter 39.35A
13 RCW; or contracts and purchases for the printing of election ballots,
14 voting machine labels, and all other election material containing the
15 names of candidates and ballot titles.

16 (5) Nothing in this section shall prohibit the legislative
17 authority of any county from allowing for preferential purchase of
18 products made from recycled materials or products that may be recycled
19 or reused.

20 **Sec. 8.** RCW 36.32.250 and 1991 c 363 s 58 are each amended to read
21 as follows:

22 No contract for public works may be entered into by the county
23 legislative authority or by any elected or appointed officer of the
24 county until after bids have been submitted to the county upon
25 specifications therefor. Such specifications shall be in writing and
26 shall be filed with the clerk of the county legislative authority for
27 public inspection. An advertisement shall be published in the county
28 official newspaper stating the time and place where bids will be
29 opened, the time after which bids will not be received, the character
30 of the work to be done, the materials and equipment to be furnished,
31 and that specifications therefor may be seen at the office of the clerk
32 of the county legislative authority. An advertisement shall also be
33 published in a legal newspaper of general circulation in or as near as
34 possible to that part of the county in which such work is to be done.
35 If the county official newspaper is a newspaper of general circulation
36 covering at least forty percent of the residences in that part of the
37 county in which such public works are to be done, then the publication
38 of an advertisement of the applicable specifications in the county

1 official newspaper shall be sufficient. Such advertisements shall be
2 published at least once at least (~~ten~~) thirteen days prior to the
3 last date upon which bids will be received. The bids shall be in
4 writing, shall be filed with the clerk, shall be opened and read in
5 public at the time and place named therefor in the advertisements, and
6 after being opened, shall be filed for public inspection. No bid may
7 be considered for public work unless it is accompanied by a bid deposit
8 in the form of a surety bond, postal money order, cash, cashier's
9 check, or certified check in an amount equal to five percent of the
10 amount of the bid proposed. The contract for the public work shall be
11 awarded to the lowest responsible bidder. Any or all bids may be
12 rejected for good cause. The county legislative authority shall
13 require from the successful bidder for such public work a contractor's
14 bond in the amount and with the conditions imposed by law. If the
15 bidder to whom the contract is awarded fails to enter into the contract
16 and furnish the contractor's bond as required within ten days after
17 notice of the award, exclusive of the day of notice, the amount of the
18 bid deposit shall be forfeited to the county and the contract awarded
19 to the next lowest and best bidder. The bid deposit of all
20 unsuccessful bidders shall be returned after the contract is awarded
21 and the required contractor's bond given by the successful bidder is
22 accepted by the county legislative authority. In the letting of any
23 contract for public works involving less than ten thousand dollars,
24 advertisement and competitive bidding may be dispensed with on order of
25 the county legislative authority. Immediately after the award is made,
26 the bid quotations obtained shall be recorded and open to public
27 inspection and shall be available by telephone inquiry.

28 For advertisement and competitive bidding to be dispensed with as
29 to public works projects with an estimated value of ten thousand
30 dollars up to one hundred thousand dollars (~~or less~~), a county must
31 use a small works roster process as provided in RCW 39.04.155.

32 This section does not apply to performance-based contracts, as
33 defined in RCW 39.35A.020(3), that are negotiated under chapter 39.35A
34 RCW.

35 **Sec. 9.** RCW 35.22.620 and 1989 c 431 s 59 are each amended to read
36 as follows:

37 (1) As used in this section, the term "public works" means as
38 defined in RCW 39.04.010.

1 (2) A first class city may have public works performed by contract
2 pursuant to public notice and call for competitive bids. As limited by
3 subsection (3) of this section, a first class city may have public
4 works performed by city employees in any annual or biennial budget
5 period equal to a dollar value not exceeding ten percent of the public
6 works construction budget, including any amount in a supplemental
7 public works construction budget, over the budget period. The amount
8 of public works that a first class city has a county perform for it
9 under RCW 35.77.020 shall be included within this ten percent
10 limitation.

11 If a first class city has public works performed by public
12 employees in any budget period that are in excess of this ten percent
13 limitation, the amount in excess of the permitted amount shall be
14 reduced from the otherwise permitted amount of public works that may be
15 performed by public employees for that city in its next budget period.
16 Twenty percent of the motor vehicle fuel tax distributions to that city
17 shall be withheld if two years after the year in which the excess
18 amount of work occurred, the city has failed to so reduce the amount of
19 public works that it has performed by public employees. The amount so
20 withheld shall be distributed to the city when it has demonstrated in
21 its reports to the state auditor that the amount of public works it has
22 performed by public employees has been so reduced.

23 Whenever a first class city has had public works performed in any
24 budget period up to the maximum permitted amount for that budget
25 period, all remaining public works within that budget period shall be
26 done by contract pursuant to public notice and call for competitive
27 bids.

28 The state auditor shall report to the state treasurer any first
29 class city that exceeds this amount and the extent to which the city
30 has or has not reduced the amount of public works it has performed by
31 public employees in subsequent years.

32 (3) In addition to the percentage limitation provided in subsection
33 (2) of this section, a first class city with a population in excess of
34 one hundred fifty thousand shall not have public employees perform a
35 public works project in excess of fifty thousand dollars if more than
36 a single craft or trade is involved with the public works project, or
37 a public works project in excess of twenty-five thousand dollars if
38 only a single craft or trade is involved with the public works project
39 or the public works project is street signalization or street lighting.

1 In addition to the percentage limitation provided in subsection (2) of
2 this section, a first class city with a population of one hundred fifty
3 thousand or less shall not have public employees perform a public works
4 project in excess of thirty-five thousand dollars if more than one
5 craft or trade is involved with the public works project, or a public
6 works project in excess of twenty thousand dollars if only a single
7 craft or trade is involved with the public works project or the public
8 works project is street signalization or street lighting. A public
9 works project means a complete project. The restrictions in this
10 subsection do not permit the division of the project into units of work
11 or classes of work to avoid the restriction on work that may be
12 performed by day labor on a single project.

13 (4) In addition to the accounting and record-keeping requirements
14 contained in RCW 39.04.070, every first class city annually shall
15 prepare a report for the state auditor indicating the total public
16 works construction budget and supplemental public works construction
17 budget for that year, the total construction costs of public works
18 performed by public employees for that year, and the amount of public
19 works that is performed by public employees above or below ten percent
20 of the total construction budget. However, if a city budgets on a
21 biennial basis, this annual report shall indicate the amount of public
22 works that is performed by public employees within the current biennial
23 period that is above or below ten percent of the total biennial
24 construction budget.

25 After September 1, 1987, each first class city with a population of
26 one hundred fifty thousand or less shall use the form required by RCW
27 43.09.205 to account and record costs of public works in excess of five
28 thousand dollars that are not let by contract.

29 (5) The cost of a separate public works project shall be the costs
30 of materials, supplies, equipment, and labor on the construction of
31 that project. The value of the public works budget shall be the value
32 of all the separate public works projects within the budget.

33 (6) When any emergency shall require the immediate execution of
34 such public work, upon the finding of the existence of such emergency
35 by the authority having power to direct such public work to be done and
36 duly entered of record, publication of description and estimate may be
37 made within seven days after the commencement of the work. Within two
38 weeks of the finding that such an emergency existed, the city council

1 shall adopt a resolution certifying the existence of this emergency
2 situation.

3 (7) In lieu of the procedures of subsections (2) and (6) of this
4 section, a first class city may use a small works roster process and
5 award contracts ~~((under this subsection for contracts))~~ for public
6 works projects with an estimated value of one hundred thousand dollars
7 or less as provided in RCW 39.04.155.

8 ~~((a) The city may maintain a small works roster comprised of all
9 contractors who have requested to be on the roster and are, where
10 required by law, properly licensed or registered to perform such work
11 in this state.~~

12 ~~(b) Whenever work is done by contract, the estimated cost of which
13 is one hundred thousand dollars or less, and the city uses the small
14 works roster, the city shall invite proposals from all appropriate
15 contractors on the small works roster: PROVIDED, That not less than
16 five separate appropriate contractors, if available, shall be invited
17 to submit bids on any one contract: PROVIDED FURTHER, That))~~ Whenever
18 possible, the city shall invite at least one proposal from a minority
19 or woman contractor who shall otherwise qualify under this section.
20 ~~((Once a bidder on the small works roster has been offered an
21 opportunity to bid, that bidder shall not be offered another
22 opportunity until all other appropriate contractors on the small works
23 roster have been afforded an opportunity to submit a bid. Invitations
24 shall include an estimate of the scope and nature of the work to be
25 performed, and materials and equipment to be furnished.~~

26 ~~(c) When awarding such a contract for work, the estimated cost of
27 which is one hundred thousand dollars or less, the city shall award the
28 contract to the contractor submitting the lowest responsible bid.))~~

29 (8) The allocation of public works projects to be performed by city
30 employees shall not be subject to a collective bargaining agreement.

31 (9) This section does not apply to performance-based contracts, as
32 defined in RCW 39.35A.020(3), that are negotiated under chapter 39.35A
33 RCW.

34 (10) Nothing in this section shall prohibit any first class city
35 from allowing for preferential purchase of products made from recycled
36 materials or products that may be recycled or reused.

37 **Sec. 10.** RCW 35.23.352 and 1989 c 431 s 56 are each amended to
38 read as follows:

1 (1) Any second or third class city or any town may construct any
2 public works, as defined in RCW 39.04.010, by contract or day labor
3 without calling for bids therefor whenever the estimated cost of the
4 work or improvement, including cost of materials, supplies and
5 equipment will not exceed the sum of thirty thousand dollars if more
6 than one craft or trade is involved with the public works, or twenty
7 thousand dollars if a single craft or trade is involved with the public
8 works or the public works project is street signalization or street
9 lighting. A public works project means a complete project. The
10 restrictions in this subsection do not permit the division of the
11 project into units of work or classes of work to avoid the restriction
12 on work that may be performed by day labor on a single project.

13 Whenever the cost of the public work or improvement, including
14 materials, supplies and equipment, will exceed these figures, the same
15 shall be done by contract. All such contracts shall be let at public
16 bidding upon ~~((posting))~~ publication of notice calling for sealed bids
17 upon the work. The notice ~~((thereof shall be posted in a public place
18 in the city or town and by publication))~~ shall be published in the
19 official newspaper, or a newspaper of general circulation most likely
20 to bring responsive bids, ~~((once each week for two consecutive weeks
21 before))~~ at least thirteen days prior to the ~~((date fixed for opening
22 the bids))~~ last date upon which bids will be received. The notice
23 shall generally state the nature of the work to be done that plans and
24 specifications therefor shall then be on file in the city or town hall
25 for public inspections, and require that bids be sealed and filed with
26 the council or commission within the time specified therein. Each bid
27 shall be accompanied by a bid proposal deposit in the form of a
28 cashier's check, postal money order, or surety bond to the council or
29 commission for a sum of not less than five percent of the amount of the
30 bid, and no bid shall be considered unless accompanied by such bid
31 proposal deposit. The council or commission of the city or town shall
32 let the contract to the lowest responsible bidder or shall have power
33 by resolution to reject any or all bids and to make further calls for
34 bids in the same manner as the original call.

35 When the contract is let then all bid proposal deposits shall be
36 returned to the bidders except that of the successful bidder which
37 shall be retained until a contract is entered into and a bond to
38 perform the work furnished, with surety satisfactory to the council or
39 commission, in ~~((the full amount of the contract price))~~ accordance

1 with RCW 39.08.030. If the bidder fails to enter into the contract in
2 accordance with his or her bid and furnish a bond within ten days from
3 the date at which he or she is notified that he or she is the
4 successful bidder, the check or postal money order and the amount
5 thereof shall be forfeited to the council or commission or the council
6 or commission shall recover the amount of the surety bond.

7 If no bid is received on the first call the council or commission
8 may readvertise and make a second call, or may enter into a contract
9 without any further call or may purchase the supplies, material or
10 equipment and perform the work or improvement by day labor.

11 (2) The allocation of public works projects to be performed by city
12 or town employees shall not be subject to a collective bargaining
13 agreement.

14 (3) In lieu of the procedures of subsection (1) of this section, a
15 second or third class city or a town may use a small works roster
16 process and award public works contracts (~~(under this subsection for~~
17 ~~contracts))~~ with an estimated value of one hundred thousand dollars or
18 less as provided in RCW 39.04.155.

19 (~~((a) The city or town may maintain a small works roster comprised~~
20 ~~of all contractors who have requested to be on the roster and are,~~
21 ~~where required by law, properly licensed or registered to perform such~~
22 ~~work in this state.~~

23 (~~(b) Whenever work is done by contract, the estimated cost of which~~
24 ~~is one hundred thousand dollars or less, and the city uses the small~~
25 ~~works roster, the city or town shall invite proposals from all~~
26 ~~appropriate contractors on the small works roster: PROVIDED, That))~~
27 Whenever possible, the city or town shall invite at least one proposal
28 from a minority or woman contractor who shall otherwise qualify under
29 this section. ((The invitation shall include an estimate of the scope
30 and nature of the work to be performed, and materials and equipment to
31 be furnished.

32 (~~(c) When awarding such a contract for work, the estimated cost of~~
33 ~~which is one hundred thousand dollars or less, the city or town shall~~
34 ~~award the contract to the contractor submitting the lowest responsible~~
35 ~~bid.))~~

36 (4) After September 1, 1987, each second class city, third class
37 city, and town shall use the form required by RCW 43.09.205 to account
38 and record costs of public works in excess of five thousand dollars
39 that are not let by contract.

1 (5) The cost of a separate public works project shall be the costs
2 of the materials, equipment, supplies, and labor on that construction
3 project.

4 (6) Any purchase of supplies, material, equipment or services other
5 than professional services, except for public work or improvement,
6 where the cost thereof exceeds seven thousand five hundred dollars
7 shall be made upon call for bids(~~(:—PROVIDED, That the limitations~~
8 ~~herein shall not apply to any purchases of materials at auctions~~
9 ~~conducted by the government of the United States, any agency thereof or~~
10 ~~by the state of Washington or a political subdivision thereof)).~~

11 (7) Bids shall be called annually and at a time and in the manner
12 prescribed by ordinance for the publication in a newspaper (~~(published~~
13 ~~or))~~ of general circulation in the city or town of all notices or
14 newspaper publications required by law. The contract shall be awarded
15 to the lowest responsible bidder.

16 (8) For advertisement and (~~(competitive))~~ formal sealed bidding to
17 be dispensed with as to purchases between seven thousand five hundred
18 and fifteen thousand dollars, the city legislative authority must
19 authorize by resolution (~~(a)),~~ use of the uniform procedure (~~(for~~
20 ~~securing telephone and/or written quotations from enough vendors to~~
21 ~~assure establishment of a competitive price and for awarding the~~
22 ~~contracts for purchase of materials, equipment, or services to the~~
23 ~~lowest responsible bidder. Immediately after the award is made, the~~
24 ~~bid quotations obtained shall be recorded and open to public inspection~~
25 ~~and shall be available by telephone inquiry))~~ provided in RCW
26 39.04.190.

27 (9) These requirements for purchasing may be waived by resolution
28 of the city or town council which declared that the purchase is clearly
29 and legitimately limited to a single source or supply within the near
30 vicinity, or the materials, supplies, equipment, or services are
31 subject to special market conditions, and recites why this situation
32 exists. Such actions are subject to RCW 39.30.020.

33 (10) This section does not apply to performance-based contracts, as
34 defined in RCW 39.35A.020(3), that are negotiated under chapter 39.35A
35 RCW.

36 (11) Nothing in this section shall prohibit any second or third
37 class city or any town from allowing for preferential purchase of
38 products made from recycled materials or products that may be recycled
39 or reused.

1 **Sec. 11.** RCW 52.14.110 and 1984 c 238 s 3 are each amended to read
2 as follows:

3 Insofar as practicable, purchases and any public works by the
4 district shall be based on competitive bids. A formal sealed bid
5 procedure shall be used as standard procedure for purchases and
6 contracts for purchases executed by the board of commissioners. Formal
7 sealed bidding shall not be required for:

8 (1) Emergency purchases if the sealed bidding procedure would
9 prevent or hinder the emergency from being addressed appropriately.
10 The term emergency means an occurrence that creates an immediate threat
11 to life or property;

12 (2) The purchase of any materials, supplies, or equipment if the
13 cost will not exceed the sum of (~~ten~~) four thousand five hundred
14 dollars(~~(: PROVIDED, That)~~). However, whenever the estimated cost is
15 from (~~forty five hundred~~) four thousand five hundred dollars up to
16 ten thousand dollars, the commissioners (~~shall require quotations from~~
17 at least three different sources to be obtained in writing or by
18 telephone, and recorded for public perusal to assure establishment of
19 a competitive price for such purchase) may by resolution use the
20 process provided in RCW 39.04.190 to award contracts;

21 (3) Contracting for work to be done involving the construction or
22 improvement of a fire station or other buildings where the estimated

11 security and the amount thereof shall be forfeited to the public
12 hospital district.

13 (2) In lieu of the procedures of subsection (1) of this section, a
14 public hospital district may use a small works roster process and award
15 public works contracts for projects in excess of five thousand dollars
16 up to fifty thousand dollars as provided in RCW 39.04.155.

17 (3) For advertisement and formal sealed bidding to be dispensed
18 with as to purchases between five thousand and fifteen thousand
19 dollars, the commission must authorize by resolution a procedure as
20 provided in RCW 39.04.190.
