1 AN ACT Relating to violation of human remains; amending RCW
2 68.50.150; reenacting and amending RCW 9.94A.320; and prescribing
3 penalties.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 68.50.150 and 1992 c 7 s 46 are each amended to read
6 as follows:

7 ~~((Every))~~ A person is guilty of violating human remains if the
8 person ((who)) mutilates, has sexual contact with, disinters, or
9 removes from the place of interment any human remains without authority
10 of law((, shall be punished by imprisonment in a state correctional
11 facility for not more than three years, or by a fine of not more than
12 one thousand dollars, or by both)).

13 "Sexual contact" means any touching of a deceased person done for
14 the purpose of gratifying the sexual desire of the defendant.

15 Violating human remains is a class C felony.

16 **Sec. 2.** RCW 9.94A.320 and 1992 c 145 s 4 and 1992 c 75 s 3 are
17 each reenacted and amended to read as follows:
