- 1 AN ACT Relating to clarifying definitions relating to farmers; and
- 2 amending RCW 15.04.010 and 82.04.330.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 15.04.010 and 1961 c 11 s 15.04.010 are each amended 5 to read as follows:
- 6 As used in this title except where otherwise defined:
- 7 <u>"Agricultural product" means any products of horticulture, grain</u>
- 8 <u>cultivation</u>, <u>vermiculture</u>, <u>viticulture</u>, <u>animal husbandry</u>, <u>or</u>
- 9 aquaculture as defined in RCW 15.85.020, and includes but is not
- 10 limited to any plantation Christmas tree, turf, or any animal, bird, or
- 11 insect or the substances obtained from them.
- 12 "Department" means the department of agriculture.
- 13 "Director" means the director of agriculture.
- 14 <u>"Farmer" means any person engaged in the business of growing or</u>
- 15 producing for sale upon their own lands, or upon the lands in which
- 16 they have a present right of possession, any agricultural product
- 17 <u>whatsoever. "Farmer" does not mean a person selling such products</u>
- 18 exclusively at retail, persons using such products as ingredients in a
- 19 manufacturing process, or persons growing or producing such products

- 1 for their own consumption. It does not mean any person dealing in
- 2 livestock as an operator of a stockyard, slaughter house, or packing
- 3 house, nor does it mean any person who is an "extractor" within the
- 4 meaning of RCW 82.04.100.
- 5 "Person" includes any individual, firm, corporation, trust,
- 6 association, cooperative, copartnership, society, any other
- 7 organization of individuals, and any other business unit, device, or
- 8 arrangement.
- 9 **Sec. 2.** RCW 82.04.330 and 1988 c 253 s 2 are each amended to read 10 as follows:
- 11 This chapter shall not apply to any ((person in respect to the
- 12 business of growing or producing for sale upon the person's own lands
- 13 or upon land in which the person has a present right of possession, any
- 14 agricultural or horticultural produce or crop, or of raising upon the
- 15 person's own lands or upon land in which the person has a present right
- 16 of possession, any plantation Christmas tree or any animal, bird, fish,
- 17 or insect, or the milk, eggs, wool, fur, meat, honey, or other
- 18 substance obtained therefrom, or in respect to the sale of such
- 19 products)) farmer as defined in RCW 15.04.010 that sells any
- 20 agricultural product as defined in RCW 15.04.010 at wholesale ((by such
- 21 grower, producer, or raiser thereof)) or retail. This exemption shall
- 22 not apply to any person selling such products exclusively at retail or
- 23 using such products as ingredients in a manufacturing process; nor to
- 24 the sale of any animal or substance obtained therefrom by a person in
- 25 connection with the person's business of operating a stockyard or a
- 26 slaughter or packing house; nor to any person in respect to the
- 27 business of taking, cultivating, or raising timber; nor to any
- 28 association of persons whatever, whether mutual, cooperative or
- 29 otherwise, engaging in any business activity with respect to which tax
- 30 liability is imposed under the provisions of this chapter. ((As used
- 31 in this section, "fish" means fish which are cultivated or raised
- 32 entirely within confined rearing areas on the person's own land or on
- 33 land in which the person has a present right of possession.))
- This chapter shall also not apply to any persons who participate in
- 35 the federal conservation reserve program or its successor administered
