- 1 AN ACT Relating to water rights; and adding a new section to
- 2 chapter 43.27A RCW.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 43.27A RCW 5 to read as follows:
- The purpose of this section is to set forth the powers of the department to regulate the withdrawal or diversion of public waters and water or water rights related thereto including regulation based on
- 9 dates of priority or other pertinent factors. The powers set forth in

- 10 this section may be exercised whether or not a general adjudication 11 relating to the water rights involved has been conducted.
- 12 (1) In a regulatory situation (a) where a water right or all water
- 13 rights proposed for regulation by the department (as well as any right
- 14 or rights of a senior priority that the proposed regulation is designed
- 15 to protect) is or are embodied in a certificate or certificates issued
- 16 under RCW 90.03.240, 90.03.330, or 90.44.060 or a permit or permits
- 17 issued pursuant to RCW 90.03.290 or 90.44.060 or (b) where it appears
- 18 to the department that public waters are being withdrawn without any
- 19 right or other appropriate authority whatsoever, the department in its

- 1 discretion is authorized to regulate the right or rights under either 2 RCW 43.27A.190 or subsection (2) of this section.
- (2) In a regulatory situation where one or more of the water rights 3 4 proposed for regulation by the department is or are not embodied in a 5 permit or certificate as described in subsection (1) of this section, the department, as its sole and exclusive power to regulate, is 6 7 authorized to bring an appropriate action at law or in equity, 8 including seeking injunctive relief, as it may deem necessary. Where 9 actions are brought in a state court, the actions shall be initiated in 10 the superior court of the county where the point or points of diversion of the water right or rights proposed for regulation are located. If 11 12 the points of diversion are located in more than one county, the 13 department may bring the action in a county where a point of diversion 14 is located.
- 15 (3) Nothing in this section authorizes the department to accomplish 16 a general adjudication of water rights proceeding or the substantial 17 equivalent of a general adjudication of water rights. The exclusive 18 procedure for accomplishing a general adjudication of water rights is 19 under RCW 90.03.110 through 90.03.245 or 90.44.220.
- 20 (4) Nothing in this section shall have an impact on RCW 90.14.130 21 or 90.14.200.
- (5) This section does not in any way modify regulatory powers previously placed with the department except as provided in subsections (1) and (2) of this section.
- 25 (6) For purposes of this section, a flow or level established by 26 rule pursuant to RCW 90.22.020 or chapter 90.54 RCW is deemed a water 27 right embodied in a certificate issued under RCW 90.03.330.
