- 1 TO THE HONORABLE BILL CLINTON, PRESIDENT OF THE UNITED STATES, AND
- 2 TO THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF
- 3 REPRESENTATIVES, AND TO THE SENATE AND HOUSE OF REPRESENTATIVES OF THE
- 4 UNITED STATES, IN CONGRESS ASSEMBLED, AND TO THE GOVERNOR OF GUAM, AND
- 5 TO THE SPEAKER OF THE GUAM LEGISLATURE, AND TO THE GUAM DELEGATE TO
- 6 CONGRESS:
- 7 We, your Memorialists, the Senate and House of Representatives of
- 8 the State of Washington, in legislative session assembled, respectfully
- 9 represent and petition as follows:
- 10 WHEREAS, The cause of democracy around the world is the cause of
- 11 the United States; and
- 12 WHEREAS, The United States extends self-determination especially to
- 13 those peoples in territories under its jurisdiction; and
- 14 WHEREAS, The Washington State Legislature supports the efforts of
- 15 each United States territory to attain the political status best suited
- 16 to its people; and
- 17 WHEREAS, Guam became a territory of the United States in the last
- 18 century without its people being given the opportunity to freely choose
- 19 a political status; and
- 20 WHEREAS, Guam became an organized territory of the United States in
- 21 1950 with the signing of the Organic Act; and

- 1 WHEREAS, During the past two decades, neighbor island groups in the
- 2 former Trust Territory of the Pacific Islands have successfully
- 3 negotiated new political status arrangements with the United States,
- 4 which have resulted in the formation of the Commonwealth of the
- 5 Northern Mariana Islands, the Republic of Belau, the Republic of the
- 6 Marshall Islands, and the Federated States of Micronesia; and
- 7 WHEREAS, The people of Guam chose by plebiscite in 1976 the
- 8 political status of commonwealth; and
- 9 WHEREAS, After extensive public debate, the people of Guam ratified
- 10 the draft Guam Commonwealth Act in 1987; and
- 11 WHEREAS, The Guam Commonwealth Act has been introduced in the
- 12 United States Congress; and
- 13 WHEREAS, The people of Guam are United States citizens and should
- 14 be given all the rights of citizens under the United States
- 15 Constitution; and
- 16 WHEREAS, Guam seeks to establish through commonwealth status a just
- 17 political relationship between its people and the United States
- 18 government; and
- 19 WHEREAS, Commonwealth status would provide for the rights of the
- 20 people of Guam in areas of vital interest, including land use,
- 21 immigration, taxation, and the applicability of federal laws
- 22 constraining Guam development; and
- 23 WHEREAS, There is growing national support for commonwealth status
- 24 for Guam, including policy statements and resolutions from members of
- 25 Congress, the federal administration, the National Governors
- 26 Association, the National Conference of State Legislatures, the Western
- 27 Legislative Conference of the Council of State Governments, and the
- 28 United States Conference of Mayors; and
- 29 WHEREAS, The Washington State Legislature supports the efforts of
- 30 the people of Guam to achieve commonwealth status within a just and
- 31 permanent relationship with the United States;
- NOW, THEREFORE, Your Memorialists respectfully pray that the United
- 33 States government allow the people of Guam to determine their own
- 34 political, social, and economic future.
- 35 BE IT RESOLVED, That copies of this Memorial be immediately
- 36 transmitted to the Honorable Bill Clinton, President of the United
- 37 States, the Governor of Guam, the Speaker of the Guam Legislature, the
- 38 Guam delegate to Congress, the President of the United States Senate,
