BE IT RESOLVED, BY THE SENATE AND HOUSE OF REPRESENTATIVES OF THE STATE OF WASHINGTON, IN LEGISLATIVE SESSION ASSEMBLED:

3 THAT, At the next general election to be held in this state there 4 shall be submitted to the qualified voters of the state for their 5 approval and ratification, or rejection, an amendment to Article VII, 6 section 11 of the Constitution of the state of Washington to read as 7 follows:

Article VII, section 11. Nothing in this Article VII as amended 8 9 shall prevent the legislature from providing, subject to 10 conditions as it may enact, that the true and fair value in money (a) 11 of farms, agricultural lands, standing timber and timberlands, ((and)) (b) of other open space lands which are used for recreation or for 12 enjoyment of their scenic or natural beauty, or (c) the land on which 13 14 is sited one detached single-family dwelling, including a mobile home, 15 when such land is zoned or classified for more intensive use shall be 16 based on the use to which such property is currently applied, and such values shall be used in computing the assessed valuation of such 17 18 property in the same manner as the assessed valuation is computed for 19 all property.

- 4 every legal newspaper in the state.
