- 1 AN ACT Relating to the local vessel excise tax; and adding new
- 2 sections to chapter 82.49 RCW.

- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 82.49 RCW 5 to read as follows:
- 6 The counties shall contract, at least six months prior to the
- effective date of a resolution or ordinance imposing a local excise tax
- 8 the privilege of using a vessel under RCW 82.49.070, the
- administration and collection to the state department of licensing, 9
- 10 which shall deduct a percentage amount, as provided by contract, not to
- exceed two percent of the taxes collected for administration and 11
- 12
- collection expenses incurred by the department. Any county with such

resolution or ordinance in effect on the effective date of this act

- 14 shall enter into such contract with the department within sixty days
- 15 after the effective date of this act. The remainder of any portion of
- any local vessel excise tax authorized by this chapter which is 16
- 17 collected by the department of licensing shall be deposited by the
- department in the local vessel excise tax account hereby created in the 18
- 19 state treasury. Moneys in the local vessel excise tax account may be

- 1 spent only for distribution to counties imposing a local vessel excise
- 2 tax. The director of licensing shall by rule set up administrative
- 3 procedures for the collection of the local vessel excise tax in
- 4 conjunction with collection of the state watercraft excise tax under
- 5 RCW 82.49.030. All earnings of investments of balances in the local
- 6 vessel excise tax account shall be credited to the local vessel excise
- 7 tax account and distributed to the counties imposing the local vessel
- 8 excise tax monthly.
- 9 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 82.49 RCW 10 to read as follows:
- 11 Monthly the state treasurer shall make distribution from the local
- 12 vessel excises tax account to the counties the amount of tax collected
- 13 on behalf of each county, less the deduction provided for in section 1
- 14 of this act. The state treasurer shall make the distribution under
- 15 this section without appropriation.
- In the event that any ordinance or resolution imposes a local
- 17 vessel excise tax at a rate in excess of the applicable limits
- 18 contained in this chapter, such ordinance or resolution shall not be
- 19 considered void in toto, but only with respect to that portion of the
- 20 rate which is in excess of such applicable limits.
