- 1 AN ACT Relating to poison information centers; amending RCW
- 2 18.76.010, 18.76.030, and 18.76.060; adding new sections to chapter
- 3 18.76 RCW; creating a new section; and repealing RCW 18.76.040.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 18.76.010 and 1987 c 214 s 16 are each amended to read 6 as follows:
- 7 The legislature finds that accidental and purposeful exposure to
- 8 drugs, poisons, and ((poisonous)) toxic substances continues to be a
- 9 severe health problem in the state of Washington. It further finds
- 10 that a significant reduction in the consequences of such accidental
- 11 exposures ((have)) has occurred as a result of the services provided by
- 12 poison information centers.
- 13 The purpose of this chapter is to reduce morbidity and mortality
- 14 associated with overdose and poisoning incidents by providing emergency
- 15 telephone assistance and treatment referral to victims of such
- 16 incidents, by providing immediate treatment information to health care
- 17 professionals, and public education and prevention programs. Further,
- 18 the purpose is to improve utilization of drugs by providing information
- 19 to health professionals relating to appropriate therapeutic drug use.

- The legislature recognizes that enhanced cooperation between the 1 emergency medical system and poison control centers will aid in 2 3 responding to emergencies resulting from exposure to drugs, poisons, 4 and ((poisonous)) toxic substances, and that, by providing telephone assistance to individuals with possible exposure to these substances, 5 the need for emergency room and professional office visits will be 6 7 reduced. As a result the cost of health care to those who may have 8 exposures to drugs, poisons, and toxic substances will be avoided and 9 appropriate treatment will be assured.
- 10 **Sec. 2.** RCW 18.76.030 and 1987 c 214 s 17 are each amended to read 11 as follows:
- The department shall, in a manner consistent with this chapter, 12 provide support for the state-wide program of poison and drug 13 14 information services ((conducted by poison information centers located 15 in the cities of Seattle and Spokane and satellite units located in the cities of Tacoma and Yakima)). These services shall, no later than 16 June 30, 1993, be centralized in and coordinated by a single nonprofit 17 18 center to be located in a place determined by the secretary. The services of this ((program)) center shall be: 19
- (1) Twenty-four hour emergency telephone management and treatment referral of victims of poisoning and overdose incidents, to include determining whether treatment can be accomplished at the scene of the incident or transport to an emergency treatment or other facility is required, and carrying out telephone follow-up to assure that adequate care is provided;
- 26 (2) <u>Providing information</u> to health professionals involved in 27 management of poisoning and overdose victims;
- 28 (3) <u>Coordination and development of community education programs</u>
 29 designed to inform the public <u>and members of the health professions</u> of
 30 poison prevention <u>and treatment</u> methods((; and
- 31 (4) Information to health professionals regarding appropriate
 32 therapeutic use of medications, their compatibility and stability, and
 33 adverse drug reactions and interactions)) and to improve awareness of
 34 poisoning and overdose problems, occupational risks, and environmental
 35 exposures; and
- (4) Coordination of outreach units whose primary functions shall be to inform the public about poison problems and prevention methods, how to utilize the poison center, and other toxicology issues.

- 1 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 18.76 RCW
- 2 to read as follows:
- 3 The department shall establish a system for consulting with other
- 4 state and local agency programs concerned with poisons and poisonings,
- 5 incidents involving exposures to potentially poisonous substances, and
- 6 other toxicological matters to develop the most coordinated and
- 7 consistent response to such situations as is reasonably possible.
- 8 **Sec. 4.** RCW 18.76.060 and 1987 c 214 s 21 are each amended to read 9 as follows:
- 10 (1) A person may not act as a poison center medical director or
- 11 perform the duties of poison information specialists of a poison
- 12 information center without being certified by the secretary under this
- 13 chapter.
- 14 (2) Notwithstanding subsection (1) of this section, if a poison
- 15 center medical director terminates certification or is decertified,
- 16 that poison center medical director's authority may be delegated by the
- 17 department to any other person licensed to practice medicine and
- 18 surgery under chapter 18.71 RCW or osteopathy and surgery under chapter
- 19 18.57 RCW for a period of thirty days, or until a new poison center
- 20 medical director is certified, whichever comes first.
- 21 <u>NEW SECTION.</u> **Sec. 5.** A new section is added to chapter 18.76 RCW
- 22 to read as follows:
- The center may receive gifts, grants, and endowments from public or
- 24 private sources that may be made from time to time, in trust or
- 25 otherwise, for the use and benefit of the purposes of the center and
- 26 spend gifts, grants, or endowments or any income from the public or
- 27 private sources according to their terms.
- 28 <u>NEW SECTION.</u> **Sec. 6.** RCW 18.76.040 and 1987 c 214 s 18 & 1980 c
- 29 178 s 3 are each repealed.
- 30 <u>NEW SECTION.</u> **Sec. 7.** If specific funding for the purposes of this
- 31 act is not provided by June 30, 1993, this act shall be null and void.
