- 1 TO THE HONORABLE BILL CLINTON, PRESIDENT OF THE UNITED STATES, AND
- 2 TO THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF
- 3 REPRESENTATIVES, AND TO THE SENATE AND HOUSE OF REPRESENTATIVES OF THE
- 4 UNITED STATES, IN CONGRESS ASSEMBLED:
- 5 We, your Memorialists, the Senate and House of Representatives of
- 6 the State of Washington, in legislative session assembled, respectfully
- 7 represent and petition as follows:
- 8 WHEREAS, Harbor seals and sea lion populations have greatly
- 9 expanded in recent years due to absolute protection afforded them under
- 10 the Federal Marine Mammal Protection Act; and
- 11 WHEREAS, Seals and sea lions are active predators upon anadromous
- 12 fish such as salmon and steelhead trout; and
- 13 WHEREAS, Anadromous fish populations are significantly reduced in
- 14 numbers throughout Washington state and some stocks have been listed as
- 15 threatened or endangered species; and
- 16 WHEREAS, Many more stocks of anadromous fish have been requested
- 17 for listing as threatened or endangered species; and
- 18 WHEREAS, Many more anadromous fish stocks are likely to be listed
- 19 as threatened or endangered; and
- 20 WHEREAS, In order to allow certain salmon and steelhead populations
- 21 to recover to, and be sustained at, viable levels it will be necessary

- 1 to have more flexibility to actively manage seals and sea lions in
- 2 identifiable areas where they cause unacceptable mortality levels in
- 3 specific fish runs; and
- 4 WHEREAS, The lethal removal of seals and sea lions is currently
- 5 prohibited under the Federal Marine Mammal Protection Act in most all
- 6 cases; and
- 7 WHEREAS, It is time that the federal government allow that
- 8 predacious seals and sea lions be killed in order for salmon and
- 9 steelhead to be allowed a reasonable chance to survive;
- 10 NOW, THEREFORE, Your Memorialists respectfully pray that the Marine
- 11 Mammal Protection Act be modified to provide for reasonable, balanced,
- 12 and prudent population levels of seals and sea lions in the state of
- 13 Washington and also provide for the active management of abundant
- 14 populations at set levels determined with modern wildlife management
- 15 science by federal and state management agencies, including the use of
- 16 lethal removal when and where necessary.
- 17 BE IT RESOLVED, That copies of this Memorial be immediately
- 18 transmitted to the Honorable Bill Clinton, President of the United
- 19 States, the President of the United States Senate, the Speaker of the
- 20 House of Representatives, and each member of Congress from the State of
- 21 Washington.
