1 AN ACT Relating to the containment of waste materials; and adding
2 a new section to chapter 70.93 RCW.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 NEW SECTION. **Sec. 1.** A new section is added to chapter 70.93 RCW
5 to read as follows:

6 (1) By January 1, 1994, each county or city with a staffed transfer
7 station or landfill in its jurisdiction shall adopt an ordinance to
8 reduce litter from vehicles. The ordinance shall require the operator
9 of a vehicle transporting solid waste to a staffed transfer station or
10 landfill to secure or cover the vehicle's waste in a manner that will
11 prevent spillage. The ordinance may provide exemptions for vehicle
12 operators transporting waste that is unlikely to spill from a vehicle.

13 The ordinance shall, in the absence of an exemption, require a fee,
14 in addition to other landfill charges, for a person arriving at a
15 staffed landfill or transfer station without a cover on the vehicle's
16 waste or without the waste secured.

17 (2) The fee collected under subsection (1) of this section shall be
18 deposited, no less often than quarterly, with the city or county in
19 which the landfill or transfer station is located.

1 (3) A vehicle transporting sand, dirt, or gravel in compliance with
2 the provisions of RCW 46.61.655 shall not be required to secure or
3 cover a load pursuant to ordinances adopted under this section.
