1 AN ACT Relating to child care; amending RCW 74.13.0903; creating a
2 new section; and declaring an emergency.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 NEW SECTION. **Sec. 1.** The legislature finds that building a system
5 of quality, affordable child care requires coordinated efforts toward
6 constructing partnerships at state and community levels. Through the
7 office of child care policy, the department of social and health
8 services is responsible for facilitating the coordination of child care
9 efforts and establishing working partnerships among the affected
10 entities within the public and private sectors. Through these
11 collaborative efforts, the office of child care policy encouraged the
12 coalition of locally based child care resource and referral agencies
13 into a state-wide network. The state-wide network, in existence since
14 1989, supports the development and operation of community-based
15 resource and referral programs, improves the quality and quantity of
16 child care available in Washington by fostering state-wide strategies,
17 and generates then nurtures effective public-private partnerships. The
18 state-wide network provides important training, standards of service,
19 and general technical assistance to its locally based child care

1 resource and referral programs. The locally based programs enrich the
2 availability, affordability, and quality of child care in their
3 communities.

4 **Sec. 2.** RCW 74.13.0903 and 1991 sp.s. c 16 s 924 are each amended
5 to read as follows:

6 The office of ~~((the))~~ child care ~~((resources coordinator))~~ policy
7 is established to operate under the authority of the department of
8 social and health services. The duties and responsibilities of the
9 office ~~((shall))~~ include, but are not limited to, the following, within
10 appropriated funds:

11 (1) Staff and assist the child care coordinating committee in the
12 implementation of its duties under RCW 74.13.090;

13 (2) Work ~~((with))~~ in conjunction with the state-wide child care
14 resource and referral network as well as local governments, nonprofit
15 organizations, businesses, and community child care advocates to create
16 local child care resource and referral organizations. These
17 organizations may carry out needs assessments, resource development,
18 provider training, technical assistance, and parent information and
19 training;

20 (3) Actively seek public and private money for distribution as
21 grants to ~~((potential or existing))~~ the state-wide child care resource
22 and referral network and to existing or potential local child care
23 resource and referral organizations~~((After the 1991-93 fiscal~~
24 ~~biennium, no grant shall be distributed that is greater than twenty-~~
25 ~~five thousand dollars))~~;

26 (4) Adopt rules regarding the application for and distribution of
27 grants to local child care resource and referral organizations. The
28 rules shall, at a minimum, require an applicant to submit a plan for
29 achieving the following objectives:

30 (a) Provide parents with information about child care resources,
31 including location of services and subsidies;

32 (b) Carry out child care provider recruitment and training
33 programs;

34 (c) Offer support services, such as parent and provider seminars,
35 toy-lending libraries, and substitute banks;

36 (d) Provide information for businesses regarding child care supply
37 and demand;

1 (e) Advocate for increased public and private sector resources
2 devoted to child care; and

3 (f) Provide technical assistance to employers regarding employee
4 child care services;

5 (5) Provide staff support and technical assistance to the state-
6 wide child care resource and referral network and local child care
7 resource and referral organizations;

8 (~~(6) ((Organize the local child care resource and referral~~
9 ~~organizations into a state-wide system;~~

10 ~~(7))~~) Maintain a state-wide child care (~~(referral)~~) licensing data
11 bank and work with department of social and health services licensors
12 to provide information to local child care resource and referral
13 organizations about licensed child care providers in the state;

14 (~~((8))~~) (7) Through the state-wide child care resource and referral
15 network and local resource and referral organizations, compile data
16 about local child care needs and availability for future planning and
17 development;

18 (~~((9))~~) (8) Coordinate with the state-wide child care resource and
19 referral network and local child care resource and referral
20 organizations for the provision of training and technical assistance to
21 child care providers; and

22 (~~((10))~~) (9) Collect and assemble information regarding the
23 availability of insurance and of federal and other child care funding
24 to assist state and local agencies, businesses, and other child care
25 providers in offering child care services.

26 NEW SECTION. Sec. 3. This act is necessary for the immediate
27 preservation of the public peace, health, or safety, or support of the
28 state government and its existing public institutions, and shall take
29 effect immediately.
