- 1 AN ACT Relating to law enforcement officers who die in the line of
- 2 duty; and adding a new chapter to Title 41 RCW.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** There is established a decoration of the
- 5 state law enforcement medal of honor with accompanying ribbons and
 - appurtenances for award by the governor in the name of the state to any
- 7 law enforcement officer who has been seriously injured or killed while
- 8 in the performance of duty, or who has been distinguished by
- 9 exceptionally meritorious conduct, upon nomination of the governor's
- 10 state law enforcement medal of honor committee.

- 11 NEW SECTION. Sec. 2. There is created the state law enforcement
- 12 medal of honor committee for nominating candidates for the award of the
- 13 state law enforcement medal of honor. The committee membership
- 14 consists of a representative from the governors office, the Washington
- 15 state law enforcement association, the Washington state council of
- 16 police officers, the Washington association of sheriffs and police
- 17 chiefs, and the Washington state troopers association. The attorney
- 18 general shall serve as chair of the committee and shall designate a

- 1 secretary for the committee. The committee shall meet not less than
- 2 semiannually to consider candidates for nomination. The committee
- 3 shall adopt rules establishing the qualifications for the state law
- 4 enforcement medal of honor, the protocol governing the decoration, and
- 5 the appurtenances necessary to the implementation of this chapter.
- 6 <u>NEW SECTION.</u> **Sec. 3.** The state law enforcement medal of honor
- 7 shall be awarded to recipients during the national law enforcement
- 8 recognition week. The governor may delegate the awarding of the medal
- 9 to the lieutenant governor or the attorney general.
- 10 <u>NEW SECTION.</u> **Sec. 4.** The state law enforcement medal of honor may
- 11 be awarded posthumously to be presented to the representative of the
- 12 deceased as may be deemed appropriate by the governor or the designees
- 13 specified in section 3 of this act.
- 14 <u>NEW SECTION.</u> **Sec. 5.** The decoration of the state law enforcement
- 15 medal of honor shall be bronze and shall consist of a police shield
- 16 overlaid by a sheriffs star with the seal of the state of Washington in
- 17 the center and the words "law enforcement medal of honor" within the
- 18 design and suspended from a ring attached by either a navy blue ribbon
- 19 with a gold edge or a green ribbon with a gold edge. Such color choice
- 20 shall be the recipient's. The reverse of the decoration shall be
- 21 inscribed with the words "For exceptionally honorable and meritorious
- 22 conduct in performing services as a law enforcement officer."
- 23 <u>NEW SECTION.</u> **Sec. 6.** Sections 1 through 5 of this act shall
- 24 constitute a new chapter in Title 41 RCW.
