- 1 AN ACT Relating to salmon labeling for human consumption; adding
- 2 new sections to chapter 69.04 RCW; creating a new section; and
- 3 prescribing penalties.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that salmon consumers
- 6 in Washington benefit from knowing the species and origin of the salmon
- 7 they purchase. The accurate identification of such species, as well as
- 8 knowledge of the country or state of origin and of whether they were
- 9 caught commercially or were farm-raised, is important to consumers.
- 10 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 69.04 RCW
- 11 to read as follows:
- 12 Unless the context clearly requires otherwise, the definitions in
- 13 this section apply throughout sections 3 through 5 of this act.
- 14 (1) "Salmon" means all species of the genus Oncorhynchus, except
- 15 those classified as game fish in Title 77 RCW, and includes:
- 16 SCIENTIFIC NAME COMMON NAME
- 17 Oncorhynchus tshawytscha Chinook salmon or king salmon
- 18 Oncorhynchus kisutch Coho salmon or silver salmon

1 Oncorhynchus keta Chum salmon

2 Oncorhynchus gorbuscha Pink salmon

3 Oncorhynchus nerka Sockeye salmon

- 4 Salmo salar (in other than Atlantic salmon
- 5 its landlocked form)
- 6 (2) "Commercially caught" means salmon harvested by commercial
- 7 fishers.
- 8 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 69.04 RCW
- 9 to read as follows:
- 10 With the exception of a commercial fisher engaged in sales of fish
- 11 to a fish buyer, no person may sell at wholesale or retail any fresh or
- 12 frozen salmon food fish or cultured aquatic salmon without identifying
- 13 the species of salmon by its common name to the buyer at the point of
- 14 sale such that the buyer can make an informed decision in purchasing.
- 15 A person knowingly violating this section is guilty of misbranding
- 16 under this chapter. A person who receives misleading or erroneous
- 17 information about the species of salmon and subsequently inaccurately
- 18 identifies salmon shall not be guilty of misbranding. This section
- 19 shall not apply to salmon that is minced, pulverized, coated with
- 20 batter, or breaded.
- 21 <u>NEW SECTION.</u> **Sec. 4.** A new section is added to chapter 69.04 RCW
- 22 to read as follows:
- 23 With the exception of a commercial fisher engaged in sales of fish
- 24 to a fish buyer, no person may sell at wholesale or retail any fresh or
- 25 frozen:
- 26 (1) Private sector cultured aquatic salmon without identifying the
- 27 product as farm-raised salmon; or
- 28 (2) Commercially caught salmon designated as food fish under Title
- 29 75 RCW without identifying the product as commercially caught salmon.
- Identification of the products under subsections (1) and (2) of
- 31 this section shall be made to the buyer at the point of sale such that
- 32 the buyer can make an informed decision in purchasing.
- 33 A person knowingly violating this section is guilty of misbranding
- 34 under this chapter. A person who receives misleading or erroneous
- 35 information about whether the salmon is farm-raised or commercially
- 36 caught, and subsequently inaccurately identifies salmon shall not be

- 1 guilty of misbranding. This section shall not apply to salmon that is
- 2 minced, pulverized, coated with batter, or breaded.
- NEW SECTION. Sec. 5. A new section is added to chapter 69.04 RCW 4 to read as follows:
- 5 To promote honesty and fair dealing for consumers, the director, in
- 6 consultation with the director of the department of fisheries, shall
- 7 adopt rules:
- 8 (1) Fixing and establishing a reasonable definition and standard of
- 9 identity for salmon for purposes of identifying and selling salmon;
- 10 (2) Enforcing sections 3 and 4 of this act.
