- 1 AN ACT Relating to interlibrary sharing; and adding new sections to
- 2 chapter 43.147 RCW.

- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 NEW SECTION. Sec. 1. In chapter 251, Laws of 1991, the
- 5 legislature enacted into law the Pacific Northwest economic region
  - agreement and made the state of Washington a party along with member
- 7 states Alaska, Idaho, Montana, and Oregon, and member Canadian
- 8 provinces Alberta and British Columbia. The legislature recognized
- 9 that the member states and provinces of the Pacific Northwest economic
- 10 region are in a strategic position to act together, as a region, thus
- 11 increasing the overall competitiveness of the members and providing
- 12 substantial economic benefits for all of their citizens.
- For those reasons, in chapter 251, Laws of 1991, the legislature
- 14 also encouraged the establishment of cooperative activities between the
- 15 seven legislative bodies of the Pacific Northwest economic region. The
- 16 member states and provinces now desire to engage in such cooperation by
- 17 electronically sharing twenty-two million volumes from certain of their
- 18 respective universities. The member states and provinces have
- 19 determined that such interlibrary sharing will provide substantial

- 1 economic benefit for their citizens. The legislature agrees,
- 2 specifically also finding that such interlibrary sharing furthers a
- 3 major component of education strategy in the 1990's and twenty-first
- 4 century, namely providing increased access to knowledge via technology.
- 5 <u>NEW SECTION.</u> **Sec. 2.** Unless the context clearly requires
- 6 otherwise, as used in sections 1 through 5 of this act "PNWER-Net"
- 7 means the technology network to be created by the member states and
- 8 provinces of the Pacific Northwest economic region that will be capable
- 9 of electronically linking the following undergraduate university
- 10 libraries of the member states and provinces:
- 11 (1) Alaska:
- 12 (a) University of Alaska, Anchorage;
- 13 (b) University of Alaska, Juneau;
- 14 (2) Alberta:
- 15 (a) University of Alberta, Calgary;
- 16 (b) University of Alberta, Edmonton;
- 17 (3) British Columbia:
- 18 (a) University of British Columbia, Vancouver;
- 19 (b) University of Victoria, Victoria;
- 20 (4) Idaho:
- 21 (a) Boise State University, Boise;
- 22 (b) University of Idaho, Moscow;
- 23 (5) Montana:
- 24 (a) Montana State University, Bozeman;
- 25 (b) University of Montana, Missoula;
- 26 (6) Oregon:
- 27 (a) Oregon State University, Corvallis;
- 28 (b) University of Oregon, Eugene;
- 29 (7) Washington:
- 30 (a) University of Washington, Seattle; and
- 31 (b) Washington State University, Pullman.
- 32 <u>NEW SECTION.</u> **Sec. 3.** (1) The PNWER-Net working subgroup is hereby
- 33 created for the member state of Washington. The working subgroup shall
- 34 be composed of seven members as follows: Two members of the senate,
- 35 one from each of the major caucuses, appointed by the president of the
- 36 senate; two members of the house of representatives, appointed by the
- 37 speaker of the house of representatives; the state librarian; and the

- 1 primary undergraduate academic librarian from each of the state's two 2 research institutions of higher education.
- 3 (2) The staff support shall be provided by the senate committee 4 services and, to the extent authorized by the chief clerk of the house 5 of representatives, by the house of representatives office of program 6 research as mutually agreed by the legislators on the working group.
- 7 (3) Legislative members shall be reimbursed for expenses in 8 accordance with RCW 44.04.120. Nonlegislative members shall be 9 reimbursed for expenses in accordance with RCW 43.03.050 and 43.03.060.
- 10 <u>NEW SECTION.</u> **Sec. 4.** The PNWER-Net working subgroup shall have 11 the following duties:
- 12 (1) To work with working subgroups from other member states and 13 provinces in an entity known as the PNWER-Net working group to develop 14 PNWER-Net;
- 15 (2) To assist the PNWER-Net working group in developing criteria to 16 ensure that designated member libraries use existing telecommunications 17 infrastructure including the internet; and
- 18 (3) To report to the legislature by December 1, 1994, concerning 19 the status of PNWER-Net.
- NEW SECTION. Sec. 5. The PNWER-Net working group may accept gifts, grants, and donations from private individuals and entities made for the purposes of sections 1 through 4 of this act.
- NEW SECTION. Sec. 6. Sections 1 through 5 of this act are each added to chapter 43.147 RCW.
