- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 46.61 RCW 6 to read as follows:
- 7 (1) The secretary of transportation shall adopt standards and
- 8 specifications for the use of traffic control devices in roadway
- 9 construction zones on state highways. A roadway construction zone is
- 10 an area where construction, repair, or maintenance work is being
- 11 conducted by public employees or private contractors, on or adjacent to
- 12 any public roadway.
- 13 (2) No person may drive a vehicle in a roadway construction zone at
- 14 a speed greater than that allowed by traffic control devices.
- 15 (3) A person found to have committed any infraction relating to
- 16 speed restrictions in a roadway construction zone shall be assessed a
- 17 monetary penalty equal to twice the penalty assessed under RCW
- 18 46.63.110. This penalty may not be waived, reduced, or suspended.

- 1 (4) A person who drives a vehicle in a roadway construction zone in 2 such a manner as to endanger or be likely to endanger any persons or 3 property, or who removes, evades, or intentionally strikes a traffic 4 safety or control device is guilty of reckless endangerment of roadway 5 workers. A violation of this subsection is a gross misdemeanor 6 punishable under chapter 9A.20 RCW.
- 7 (5) The department shall suspend for sixty days the license or 8 permit to drive or a nonresident driving privilege of a person 9 convicted of reckless endangerment of roadway workers.
- 10 **Sec. 2.** RCW 46.63.020 and 1993 c 501 s 8 are each amended to 11 read as follows:
- Failure to perform any act required or the performance of any act 12 prohibited by this title or an equivalent administrative regulation or 13 14 local law, ordinance, regulation, or resolution relating to traffic 15 including parking, standing, stopping, and pedestrian offenses, is 16 designated as a traffic infraction and may not be classified as a criminal offense, except for an offense contained in the following 17 18 provisions of this title or a violation of an equivalent administrative 19 regulation or local law, ordinance, regulation, or resolution:
