1            AN ACT Relating to higher education; and amending RCW 28B.10.710  
2 and 28B.80.350.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4            **Sec. 1.** RCW 28B.10.710 and 1969 ex.s. c 223 s 28B.10.710 are each  
5 amended to read as follows:

6            There shall be a one quarter or semester course in either  
7 Washington state history and government, or Pacific Northwest history  
8 and government in the curriculum of all teachers' colleges and  
9 teachers' courses in all institutions of higher education. No person  
10 shall be graduated from any of said schools without completing said  
11 course of study, unless otherwise determined by the state board of  
12 education. Any course in Washington state or Pacific Northwest history  
13 and government used to fulfill this requirement shall include  
14 information on the culture, history, and government of the American  
15 Indian peoples who were the first human inhabitants of the state and  
16 the region.

17            **Sec. 2.** RCW 28B.80.350 and 1992 c 60 s 3 are each amended to read  
18 as follows:

1       The board shall coordinate educational activities among all  
2 segments of higher education taking into account the educational  
3 programs, facilities, and other resources of both public and  
4 independent two and four-year colleges and universities. The four-year  
5 institutions and the state board for community and technical colleges  
6 (~~education~~) shall coordinate information and activities with the  
7 board. The board shall have the following additional responsibilities:  
8       (1) Promote interinstitutional cooperation;  
9       (2) Establish minimum admission standards for four-year  
10 institutions, including a requirement that coursework in American sign  
11 language or an American Indian language shall satisfy any (~~foreign~~  
12 ~~language~~) requirement for instruction in a language other than English  
13 that the board or the institutions may establish as a general  
14 undergraduate admissions requirement;  
15       (3) Establish transfer policies;  
16       (4) Adopt rules implementing statutory residency requirements;  
17       (5) Develop and administer reciprocity agreements with bordering  
18 states and the province of British Columbia;  
19       (6) Review and recommend compensation practices and levels for  
20 administrative employees, exempt under chapter 28B.16 RCW, and faculty  
21 using comparative data from peer institutions;  
22       (7) Monitor higher education activities for compliance with all  
23 relevant state policies for higher education;  
24       (8) Arbitrate disputes between and among four-year institutions or  
25 between and among four-year institutions and community colleges at the  
26 request of one or more of the institutions involved, or at the request  
27 of the governor, or from a resolution adopted by the legislature. The  
28 decision of the board shall be binding on the participants in the  
29 dispute;  
30       (9) Establish and implement a state system for collecting,  
31 analyzing, and distributing information;  
32       (10) Recommend to the governor and the legislature ways to remove  
33 any economic incentives to use off-campus program funds for on-campus  
34 activities; and  
35       (11) Make recommendations to increase minority participation, and  
36 monitor and report on the progress of minority participation in higher  
37 education.
