1 AN ACT Relating to international trade; adding a new section to
2 chapter 44.52 RCW; creating new sections; and providing an expiration
3 date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** The legislature finds that the expansion of
6 international trade is vital to the economy of Washington state.
7 International trade-related activities currently account for
8 approximately twenty percent of employment in this state even though
9 only a small percentage of businesses do extensive exporting.
10 Washington's long-term economic prosperity depends on the creation and
11 retention of jobs that international trade provides through providing
12 an expanded marketplace for goods and services produced in this state.
13 Increasing the number of businesses exporting and the foreign markets
14 accessed helps diversify the state economy and make the state's
15 businesses more competitive by providing experience in the
16 international marketplace. There are many international markets that
17 offer export potential for Washington businesses that are not currently
18 being accessed, particularly several Pacific Rim countries. The
19 legislature also finds that there presently exists several programs and

1 initiatives by federal, state, and local governments that have to be
2 coordinated effectively within and among economic development
3 organizations, state agencies, academic institutions, and businesses so
4 as to enhance the sale of goods and services in foreign markets.

5 The legislature further finds that a strategy to expand
6 international trade must be integrated into a comprehensive long-term
7 economic development plan, and that the expertise of the private sector
8 can enhance the joint strategic planning efforts of the governor,
9 executive agencies, and the legislature.

10 Therefore, the legislature declares that an important public
11 purpose can be accomplished through an international trade council
12 that, through coordination and advice, can facilitate increased
13 exporting by Washington businesses.

14 NEW SECTION. **Sec. 2.** A new section is added to chapter 44.52 RCW
15 to read as follows:

16 (1) The council on international trade is established. The council
17 shall consist of fifteen members as follows:

18 (a) Two members of trade organizations, appointed by the governor;

19 (b) Two representatives of ports, appointed by the governor;

20 (c) Two representatives of businesses active in exporting goods,
21 appointed by the governor;

22 (d) Three representatives from the executive-legislative committee
23 on economic development created in chapter . . . (Senate Bill No.
24 5300), Laws of 1993;

25 (e) Two members with experience in foreign marketing, appointed by
26 the governor;

27 (f) Two experts in financing export transactions, appointed by the
28 governor;

29 (g) The director of the department of trade and economic
30 development or the director's designee; and

31 (h) The director of the department of agriculture or the director's
32 designee.

33 (2) Nonlegislative members may receive reimbursement from the
34 governor's office for travel under RCW 43.03.050 and 43.03.060.
35 Legislative members may be reimbursed under RCW 41.04.300.

36 (3) The council shall:

1 (a) Advise the executive-legislative committee on economic
2 development regarding policies, programs, and activities to enhance the
3 exporting of Washington goods and services to international markets;

4 (b) Review current state export targeting efforts and advise the
5 executive-legislative committee on economic development regarding
6 markets with potential that currently are not being emphasized;

7 (c) Assist in the coordination of public export programs state-
8 wide;

9 (d) Identify for the executive-legislative committee on economic
10 development current and long-term international trade issues that need
11 to be addressed by the state in its long-term economic development
12 plan;

13 (e) Recommend methods to increase the awareness of international
14 trade, especially its opportunities and its importance, throughout the
15 state;

16 (f) Study the impact of the Uruguay round of the general agreement
17 on tariffs and trade and the north american free trade agreement on the
18 state's small manufacturing and export firms, focusing on the
19 competitive threats and opportunities presented by the trade agreements
20 to the state's six most significant traded sectors as measured by the
21 number of employees in the sector and the aggregate dollar volume of
22 goods and services traded in the sector. The counsel shall identify
23 and utilize existing analyses, studies, and data from the federal
24 government, national and state business and labor organizations, and
25 educational and policy institutes.

26 NEW SECTION. **Sec. 3.** The council may accept gifts, grants,
27 donations, devises, and bequests to facilitate the work of the council.

28 ****NEW SECTION. Sec. 4. The council shall make a preliminary report***
29 ***to the executive-legislative committee on economic development on its***
30 ***activities by June 1, 1994, and make a final report by December 1,***
31 ***1994.***

32 **Sec. 4 was vetoed, see message at end of chapter.*

33 NEW SECTION. **Sec. 5.** This act shall expire on June 30, 1995.

Passed the House April 25, 1993.

Passed the Senate April 25, 1993.

Approved by the Governor May 18, 1993, with the exception of
certain items which were vetoed.

Filed in Office of Secretary of State May 18, 1993.

1 Note: Governor's explanation of partial veto is as follows:

2 "I am returning herewith, without my approval as to section 4,
3 Substitute House Bill No. 1808 entitled:

4 "AN ACT Relating to international trade;"

5 I am a strong believer in the importance of international trade for
6 the future of the state economy. Washington State is open to the
7 world, and trade is a critically important part of our economy. I
8 believe that collaboration between the state and the private sector on
9 improving our trade activities and our international efforts will give
10 us better results.

11 Because trade is so important for the state, I am signing this
12 legislation despite my concern for its impact on affected state
13 agencies. The coming year will be a challenging and difficult one for
14 state economic development work. The upcoming merger of the
15 departments of Trade and Economic Development and Community
16 Development, and the budget reductions in the Department of Trade and
17 Economic Development will create some real problems.

18 I am vetoing section 4 of this bill, that directs the new Council
19 to report to the Executive-Legislative Committee on Economic
20 Development which would be established in Senate Bill No. 5300.
21 Because I am vetoing that legislation, the reporting requirement
22 contained in section 4 could not be implemented. Instead, I am
23 directing the Council on International Trade established in this bill
24 to make its reports to the legislature and to the Governor.

25 With the exception of section 4, Substitute House Bill No. 1808 is
26 approved."
