## STATE ELECTED OFFICIALS--SALARIES

Effective Date: 9/1/93

AN ACT Relating to salaries of elected officials; and amending RCW  $43.03.011,\ 43.03.012,\ and\ 43.03.013.$ 

## BE IT ENACTED BY THE WASHINGTON CITIZENS' COMMISSION ON SALARIES FOR ELECTED OFFICIALS:
